## **KAUTION KORNER**

### **Blind Spots**

Today's safety tip is a short one, but is intended to help you avoid one of the more common causes of rider injury. Blind spots.

A motorcycle is already a small target to be spotted by motorists without our causing ourselves to be even less visible. Where are you invisible? Recently an attorney acquaintance of mine was nearly killed in a totally avoidable accident. He spent months in the hospital and walks with a cane years later because of a momentary failure to observe proper spacing. He was heading south in the left lane of a four lane road through his home town of Northbrook. Yes, he was only a couple of miles from home. He was following a truck at a reasonable stopping distance as he went through an intersection. What he did not realize was that stopping distance was not the problem. He was in the right track, and was totally invisible to the northbound car that turned left as soon as he passed the truck, running right into the following bike.

While the "invisible follow" is the most common accident magnet that I have heard about, it is not by any means the only one. How often have you heard about a bike being run over by a following 18 wheeler pulling away from an intersection? They can't see you when they pull up too close, and it doesn't take much inattention to forget you are there. Darned good reason to keep the bike in gear at an intersection.

What about being in front of a truck, but in an adjacent lane? Ever see those great big mirrors on a truck. Ever occur to you that the driver can't see you if the mirror complete blocks you out?

No problem? What if he changes lanes while you are slowing down for a traffic light. Bam.

You also shouldn't stay beside a truck any longer than necessary. Yes, you can see the driver's eyes in the outside mirrors, but that doesn't mean he or she is paying attention to you instead of a cell phone or CB radio. Even if the driver looks in the mirror before changing lanes or turning, he is probably looking for something with four wheels. First life threatening close call I had when I returned to riding involved a truck that turned left from the right lane, which is where I happened to be trying to go straight. Ever look at the rear wheels of a tractor headed straight for you while you are braking as hard as you can, bailing out as soon as you get stopped, and rolling out of the way to avoid getting run over?

Is a truck following rather closely? If so, either let him get by, or be sure you have a lot of room in front of you. Keep in mind that a bike can stop quicker than most other vehicles, so your only safety cushion may be in front of you if you are being crowded and cannot move over. Be sure you don't overdo it and make the following driver think you are leaving all that extra space just to taunt him.

I am using the word TRUCK generically here, since you are just as likely to be hidden from sight by a Tahoe with tinted windows as you are by a UPS truck. You are almost always in control of positioning, make the most of it and save your life.



## Florida Escape... Finding Green

Once upon a time Ponce De Leon landed in Florida seeking the fabled fountain of youth, and although he was unsuccessful in his quest, our semi tropical road trip may have been the youthful elixir that we needed to lengthen our riding season. The Florida peninsula, with its extensive coastline along the Gulf of Mexico and Atlantic Ocean, is a vast breathtaking diversity of world-class beaches and forgotten small towns where time stands still. Only Alaska has more miles of oceanfront, but, while Terri loves her beaches, she was not willing to go to Alaska in the winter. The inland dense pine forests gave way to wide open prairies with grazing cattle, lush vegetable farms and orchards while the lower portion of the state was sawgrass prairie and mangrove swamps with a few stunted cypress trees thrown in for good measure.



We allowed for 11 days to enjoy this 2000 mile jaunt along the back roads of the Florida coastline and took us to within shouting distance of every major metropolitan area in the state without getting tangled up in any of the local congestion. So come along with us for just a sampling of our Florida Escape...

### Day 01 (Circling Apalachicola – 205 Miles)

We arrived in Midway Florida a day early and decided to loop the Apalachicola National Forest as the centerpiece of getting our feet wet. Following US 90 west to Grand Ridge, then turning south to Bristol on Highway 71 provided the two-lane back roads with yellow pine forests, savanna, cyprus and wildflowers along the way.

A short stop in Wewahitchka found us searching for that famous Tupelo Honey. A soft-spoken gentleman that has lived in "Wewa" since 1933 directed us down a side street to the first palm tree and turn left follow that road to the chain-link fence where you would find L. L. Lanier, a local beekeeper that bottles the Tupelo Honey right on site from the flowers of the White (Ogeechee) Tupelo Trees which bloom for two weeks every spring in the southeast-



ern swamps of Florida. The Ogeechee River, the Apalachicola, and the Chattahoochee River Basins that run through the forest are the only place in the world where Tupelo Honey is produced commercially.

It was off to the gulf coast and around Indian Pass to the little gulf side town of Apalachicola where we dined on the freshest of fresh seafood lunch in a little seaside bistro on the edge of the bay. Just in case you ever get to Apalachicola, stop in and have some shrimp, crab cakes or oysters at Boss Oyster.



### Day 02 (Midway FL to Cheifland, FL - 238 Miles)

This was the first day of the "Ride". So as not to retrace the previous day's route, we decided to trek down SR-67 through the heart of the Apalachicola National Forest.

At our next stop the town of Carrabelle seemed like time stood still. We stopped and met some locals at the only coffee shop in town (Terri needed her Cappuccino).



There was also this phone booth... Yes, a single phone booth that has served as a police station since 1963 until just last year for the 1800 citizens who live in Carrabelle. It is confirmed by the locals that those who protect and served this community parked their patrol

car in the shade of the berry tree next to the booth. It was known as "The Smallest Police Station in the World."

Following US-98 east took us to within a few feet of the gulf waters as we hugged the coastline but then turned inland through acres of cultivated pinewood forests to the City of Perry and around Florida's big bend with a few deviations down SR-361 and SR-358 to stay away from the four-lane highways.

## Day 03 (Cheifland, FL to Clearwater Beach, FL – 215 Miles):

We began this day in Chiefland and proceeded southwest along the lower reaches of the Suwannee River turning west to the remote, picturesque town of Cedar Key. The view along these stretches of road to Cedar Key is how we understood Mother Nature intended for the coastal areas to look. From the panhandle of the state much of the coastline above Crystal River has yet to be developed and the two-lane roads were quiet and sometimes desolate.

Following US 19 south to US 44 took us inland thru scenic central Florida with cypress trees and spanish moss creating a cavern of overhanging trees emerging into the orange groves of central Lake County and then looping back to the coast staying well clear of congestion of Tampa we hugged the coastline of SR -19A at Tarpon Springs to end the day in Clearwater Beach.

After we checked in at the lodge, down on the beach, Terri did not know it but seagulls are aggressive; show them a few potato chips on the beach and a flock by the hundreds swarmed over her like Tippi Hedren in "The Birds" just to get that chip. As they say in social media sites, I was LMAO.



## Day 04 (Clearwater Beach to Ft Meyers - 179 Miles)

For those of you enamored of long bridges, the ride across Tampa Bay on the Sunshine Skyway Bridge was

extra exciting even though the tanker alongside us decided he wanted to race while I snapped photos of the bridge. We complemented the crossing by cutting back West from Bradenton to the barrier islands and Longboat Key with sandy beaches and emerald green Gulf of Mexico waters, working our way down through Sarasota and then inland through the Myakka River State Park where 20 something foot crocodiles lay sunning themselves on the banks of the Myakka river and eventually to Arcadia, home of the Arcadia orange. Orange groves flourished on both sides of the road as we followed truckloads of oranges direct from the pickers' hands and off to the processing plants. The rest of the route to Ft. Meyers was just a



quiet ride showcasing the way south Florida used to be before tourism consumed the area around its southwestern beaches.

## Day 05 (Ft Meyers to Homestead – 176 Miles)

Leaving Fort Myers we headed northeast along the Caloosahatchee River up to Labelle turning south to the everglades where we found there is plenty of cattle and horse farms along Route 29 which seemed more grazing lands than the stereotypical image of the everglades and swampland. The route through southern Florida took us through the big Cypress Indian Reservation, along "Alligator Alley", and Old Route 41 which is also known as the Tamiami Trail Scenic Highway. We expected this stretch of road to be fairly desolate however some cars and other riders were either in front or behind us the entire way.

At the corner of US 41 and SR-997, the Miccosukee Resort and Gaming facility rises above the horizon. This sovereign nation facility belongs to the Miccosukee Indian Tribe which has a proud history in the Florida everglades, which predates Columbus. The Miccosukee Indians were originally part of the Creek Nation, and then migrated to Florida before it became part of the United States. Here we stopped for lunch at a little R&R.



Just before Miami we turned south on SR-997 passing lush farms with rows and rows of fresh vegetables that are harvested in this region and shipped to restaurants and supermarkets throughout the states.

## Day 06 & 07 (Homestead to Key West – 132 Miles)

Setting out from Homestead early in the morning to beat the local traffic, we continued our southern trek towards the self-proclaimed Conch Republic and its capital, Key West which has been home to Pirates, writers, and presidents, and the 126 mile ride along US 1 that is more bridge than land from Key Largo to the southernmost city in the United States took us across 42 bridges, including one that was 7 miles long. Here we decided to take a break for Christmas Eve and Christmas Day. We watched sunset at Mallory Square (the nightly ritual of Key West), hung out on Duval Street with some of the characters who add the color to Key West, kicked back a few at Sloppy Joe's Bar where Hemingway once hung out and did all of the touristy things that you should do while in Key West.





## Day 08 (Key West to Clewiston – 230 Miles)

Leaving Key West we retraced our route along US 1 through Marathon, Islamorada, and Key Largo back to the mainland and through Homestead to view the same farms that we saw before continuing north towards Clewiston, on the southwest edge of Lake Okeechobee. This was a straightforward, easy cruising day back through the Keys and the vast wetland prairie of southeastern Florida.



## Day 09 (Clewiston to Cocoa Beach – 161 Miles)

Today's ride started us around the tall levee that surrounds the western side of the 730 square mile Lake Okeechobee. With a bit of exploring, it may have been possible to find an occasional ingress for views across the Lake, but otherwise the great lake was hidden from view (I did not realize that when I planned the route).

Florida is also the nation's leading producer of sugar cane and we saw miles of it between the south end of the lake and the town of Okeechobee on the north side of the lake. Harvest fires were seen in the distance and along some of the roadways to remove the dead leaf material before cutting. The fire burns at quite high

temperatures but is over very quickly so that the cane and its sugar content are not harmed.

From Okeechobee following SR-70 easterly down to Ft. Pierce at the ocean side and turning north, the cruise up SR-A1A along the barrier islands could only be rated as A-number-1. This was the archetypical Florida ride, as the first part cut through the interior wetlands and the second part follows the sandy beaches on the barrier islands. It was on this day that the weather became questionable as we knew a cold front was working its way down the panhandle. Storm clouds brewed as the winds picked up but we made it to our lodging in Cocoa Beach before the thunderstorms closed in.

## Day 10 (Cocoa Beach to St Augustine Beach – 185 Miles)

This day started out chilly and damp with heated gear and full leathers. The temperatures had dropped a full 20-degrees from the previous weeks ride. The temperature at KSU was a mere 55° but warmed up nicely as the day progressed to a high of 65°

Making our way north along SR-1 thru Titusville,

where NASA lives and breathes, the only views we had were of empty towers and buildings for the retired space shuttle program.

Heading east along SR-46 took us through a series of small friendly towns and then emerges upon historic downtown Mount Dora. This route presents one scenic view after another along the central lakes of Florida. Here we stopped for lunch and explored the quaint little trinket shops. Terri loved this town because it reminded her of Galena, shopping and more shopping; she says "if only we didn't have such limited space on the bike!?"



The route continued north through the middle of the Ocala National Forest. The forest may not look like wilderness, but it does have the highest large bear population in the state and the posted signs along the way never let us forget that. From pine trees the scenery turned to palm trees as the route headed back to the coast just north of Daytona again following SR-A1A along the barrier islands to St. Augustine Beach.

## Day 11 (St. Augustine Beach back to Midway – 261 Miles)

Again a chilly day but not as bad as expected as we geared up and headed north through St. Augustine following SR -A1A along the Atlantic coast to the historic village of Mayport. It was here that we caught St. Johns River ferry which is one of the last remaining public ferries in the state and dates back to 1948, and crossed over to Ft. George Island; the crossing took all of a whopping 5 minutes. Continuing up and around Jacksonville finally turning west and finding our way to US 90 which parallels Interstate 10; the road was mostly straight with some minor elevation changes as we passed farm and grazing land interspersed with the woodlands which is the essence of northern Florida.

It was on this last day that I went fumbling for my camera in my jacket pocket and watched it bounce twice high in the air in my rearview mirror before coming to rest in the right-hand track of the two-lane road where the truck behind me promptly finished it off. My corider of course on this trip has not let me forget that riding and taking pictures is not in the best interest of the camera.



A stop in Lake City for lunch in a little diner across from the City Hall and we were off again to our final destination of Midway Florida.

In addition to attending the mandatory annual GRASS / Road Captain training, the road captains met and discussed the following:

1. Re-qualified Road Captains and Senior Road Captains for 2012 are:

2. The qualifications for new and existing Road Captains were reviewed and discussed and will remain unchanged for 2012.



3. A policy change was approved at the Senior Road Captains Meeting to make written Mentor Reports optional except on candidates for road captain. All other mentoring feedback will be communicated through discussions (verbal or electronically) with the Road Captain being mentored.



4. The Top Cats President reminded the group that all Top Cats Road Captains must set the example for other Top Cats members and are expected to conduct themselves in a professional, and responsible manner, particularly when it comes to public conduct, alcohol use, medication use, and in any situation that could tarnish the image and reputation of the Club and set the wrong example to our members.



5. Road Captains were reminded that an official Top Cats Ride is defined as one that is scheduled on our calendar, planned, and executed by Top Cats according to our principles. It also includes rides to and /or from destinations for other organizations rides when we plan it, schedule it, and lead it.

6. Road Captain ride credit was explained, in contrast to an "Official" Top Cats ride. For credit purposes, the ride should be a "stand alone" Top Cats event, or a day within a ride that is a Top Cats event. Where the ride is not a "stand alone" Top Cats event but is part of either a long ride primarily led by another Road Captain, or if associat-



ed with a ride of another group of for a Non-Top Cats purpose, the ride will be evaluated on complexity, length, duration, and challenge to determine point value and whether it will qualify a Road Captain candidate for his/her rocker, or re-qualify a current road captain. The Safety Committee has the final determination on whether a ride counts toward re-qualification or qualification. Any concerns with the validity of a qualifying or re-qualifying ride should be addressed to the Safety Committee prior to that ride.



7. All road captains were encouraged to identify, motivate, and assist, responsible and capable Top Cats who desire and have the attributes to become, Road Captains, over the coming year.




The turnout was good, but I know we can do better and I would ask that next year, everyone contact all the folks they know in the club and "ask" them if they are going, just as a good reminder.

- ◆ Safety Tip: There are so many things that can be done to prepare the bike for next season. TCLOCS is the memory key:
  - T= Tires. Check for the many incentives available right now for new tire purchases. Treads, wheels, bearings, break pads, and sprocket or pullys are also important components to check.
  - C= Cables. Adjustments can be made now. Look for frays and cracks in the cables as well as correct tension and connections.
  - L=Lights. Checks on the battery and electrical components are essential for making it a good year.
  - O=Oils. All fluids can be checked as well.
  - C=Chain. As well as all of the parts that are involved in the forward motion of the bike.
  - S = Side stand, center stand, and/or kick stand. The spring associated with this should be checked as well.
- ◆ Law Changed for the Red Lights. New Law reads 'reasonable amount of time'. Be sure to use good judgment when making the turns. It is advisable to wait two minutes.
- ◆ Fred Rau's column identifies some bike issues. #1 is the 'construction zone' areas set up by police departments. There have been some areas identified that were not truly under construction, but speeders were fined double. #2 Some cities have illegally shortened the cycle for a yellow light to catch more drivers in a red light camera.

### **Activities/ Website: Larry Scalzitti**

- ◆ Tony Loden is open for all new ideas and rides!
- ◆ New Road Captains will be welcomed!
- ◆ Dennis Dougherty is in charge of the website, but has been out of town.
- ◆ Tony Loden reported on the activities that are coming up for January... See the website for details!


