
## YOUR BOARD... AND COMMITTEES!

Gene will have oversight of our Activities Committee, (Chaired by Tony Loden) and our Awards Committee.





## KAUTION KORNER

### What's in YOUR First Aid Kit?

We have heard many times the importance of having a First Aid Kit on our bikes. We often will be asked during a pre-ride meeting for those who do have them to raise their hands. The Top Cats have made great progress over the years raising the level of importance of carrying these kits and of course we have held First Aid and CPR courses every other year or more often.

One Web site that has a significant amount of information on this Topic is [www.firstaidanywhere.com](http://www.firstaidanywhere.com) They point out that the most common injuries for motorcycle riders are:

Burns, both major (from exhaust pipes) and minor (sunburn)

Eye Injuries (things blowing in our eyes).

Cuts, scrapes, road rash and fractures.

Then we have things such as bee stings or other allergic reactions.

These are many of the same things we learned in our first aid classes. It never hurts to be reminded often about what we may face.

Back around 2007 the Top Cats had a safety kit campaign. Over 30 kits were assembled and sold to our membership. Based on ideas similar to what the web site offers up, many items were purchased in bulk to make the kits.

One of the tips we receive often, but in many cases ignore, is to replace items in your First Aid kit each year. So of course that brings us to a real life, Top Cats Story!

This past season, I had the opportunity to need some first aid on one of our rides. While riding some great country roads near Galena, a large bumblebee ended up under my sleeve and on my shoulder. It proceeded to sting me multiple times. Due to some past issues, I was concerned about a possible reaction.



Our Road Captain

pulled us over. It was my intention to take some Benadryl as a precautionary measure. Tony Loden did have an epi pen, which would have been handy if a reaction took place. Greg Smith looked in his first aid kit and pulled out some Benadryl. The only issue was it had expired 5 years ago. With no stores in sight, the old Benadryl would hopefully do the trick, which turned out to be true.



When I got home I pulled out my own first aid kit and discovered that mine had some old expired Benadryl in it as well, along with a whole bunch of other old stuff.

So not only did my kit have old stuff in it, I had no idea it was even in there. The truth is that in my mind the kit was not that old, maybe a year or two. Whenever I heard someone remind us to replace items in our kits, I simply thought good idea, when mine gets old!

Most of the items in our kits do expire. The alcohol wipes dry out, band aids lose adhesive strength and drugs lose their potency.

Let's make this winter the season that everyone checks their First Aid Kits, replaces the old items, and understands what they have. Don't have a first aid kit? Perhaps this is the year to get one.




### AMA Opposes Task Force's Recommendation for Federal Mandatory Helmet Laws

A federal task force is poised to recommend that all states have mandatory helmet laws for all motorcyclists, which the task force says would reduce injuries and deaths as well as result in economic benefits, the American Motorcyclist Association (AMA) reports.



The AMA has expressed its belief that motorcyclists would be best served if regulators and legislators focus on programs to prevent motorcycle crashes from occurring in the first place. The AMA also said that any economic benefits would be insignificant since health care costs related to motorcycle crashes are miniscule in the context of total health care costs nationwide.

"The AMA continues to strongly encourage the use of personal protective equipment, including gloves, sturdy footwear and a properly fitted motorcycle helmet certified by its manufacturer to meet federal safety standards," said Wayne Allard, AMA vice president for government relations. "But we also believe that adults should have the right to voluntarily choose to wear a helmet."

The Community Preventive Services Task Force, whose 15 members are appointed by the director of the Centers for Disease Control and Prevention (CDC), makes recommendations to the CDC and reports to the U.S. Congress about community preventive services, programs and policies to improve health. The task force is preparing to recommend that all states have universal helmet laws, which

means that all riders, regardless of age, would be required to wear helmets.



The task force is ready to make the recommendation based on its belief that a universal helmet mandate would reduce motorcyclist deaths and injuries, and that mandating riders to wear helmets would result in economic benefits. The task force believes health care costs for injured helmeted riders wouldn't be as high as those of injured unhelmeted riders, and that universal helmet laws would result in fewer missed days of work for injured riders.



Explaining the AMA's opposition to the proposed recommendation, Allard cited the official AMA position on voluntary helmet use.

"The AMA strongly advocates helmet use, but helmet use alone is insufficient to ensure a motorcyclist's safety," said Allard. "There is a broad range of measures that can be implemented to improve the skill of motorcycle operators, as well as reduce the frequency of situations where other vehicle operators are the cause of crashes that involve motorcycles."

In its position on voluntary helmet use, the AMA noted that mandatory helmet laws do nothing to prevent crashes.

"The AMA supports actions that help riders avoid a crash from occurring, including voluntary rider education, improved licensing and testing, and expanded motorist awareness programs," said Allard. "This strategy is widely recognized and pursued in the motorcycling community."

Concerning the task force claim of economic benefits, the AMA noted that injured motorcyclists are less likely than the general population to use public funds to pay for injuries sustained in crashes, and are just as likely to be insured as other vehicle operators.

In addition, the AMA said the costs associated with the treatment of motorcyclist injuries account for a tiny fraction of total U.S. health care costs. An even smaller portion of these costs is attributable to unhelmeted motorcyclists, the majority of which are paid by privately purchased insurance.

"When the gates open at Mid-Ohio on July 18-20, riders, fans and racers know they'll find racing in all vintage disciplines,

North America's largest motorcycle swap meet, seminars, demo rides, special exhibits and much more – with all riders and types of motorcycles welcome. We'll be announcing more details soon, so make your plans now."

Activities include the AMA Racing Vintage Grand Championship, which features road racing, motocross, hare scrambles, trials and dirt-track racing; North America's largest motorcycle swap meet; bike shows and awards; stunt shows; demo rides of current production bikes; and seminars on a number of topics by noted motorcycling experts.

All proceeds from AMA Vintage Motorcycle Days benefit the AMA Motorcycle Hall of Fame. The goal of the Hall of Fame, located on the AMA campus in Pickerington, Ohio, is to tell the stories and preserve the history of motorcycling's legends and heroes. **Lake Shore Harley-Davidson**, which was [facing foreclosure](#) is the newest addition to the Revolution Motorsports group.



The Revolution Motorsports group includes **Chicago Harley-Davidson** stores (Glenview and a downtown gear store); as well as **Renegade Harley-Davidson** in Alexandria, downtown gear stores **Voodoo Harley-Davidson** and **Bourbon Street Harley-Davidson** in -

New Orleans, and New Orleans Harley-Davidson in Metairie, Louisiana; Smokin' Harley-Davidson in Winston-Salem, N.C.; and Harley-Davidson of Cool Springs in Franklin, Tenn.

Not much is expected to change physically at the Lake Shore dealership. The new owners will retain the name and 80,000 sq. ft. showroom and service center in Libertyville.

The new management took ownership Nov. 19 and reopened Nov. 20 without a hitch. Now plans include adding staff, adding digital and other merchandising enhancements and expanding customer events.

“We will be doing more hiring. We’re going to have enough staff to meet the customer needs. Right now we feel we need to add some people across the store,” Gordon said. “We fully intend to commit to a full-blown marketing effort to bring excitement to the dealership – bike nights, events and fun activities that that Harley-Davidson riders will enjoy.”

## U.S. motorcycle thefts dropped 1%


Four Japanese OEMs’ motorcycles were the most stolen bikes in the United States last year, with Harley-Davidson rounding out the top five in a year that saw motorcycle thefts decline overall by 1 percent.



A total of 46,061 motorcycles were reported stolen in 2012 compared with 46,667 reported stolen in 2011 – a decrease of 606 thefts or 1 percent, according to the National Insurance Crime

Bureau (NICB). The NICB report is based on National Crime Information Center (NCIC) motorcycle theft data for 2012.

American Honda Motor Co., Inc. had the highest reported thefts in 2012 with 9,082. In second place was Yamaha Motor Corp. with 7,517. Third was American Suzuki Motor Corp. (7,017), followed by Kawasaki Motors Corp., U.S.A. (4,839) and Harley Davidson, Inc. (3,755).



More motorcycle thefts happened in California than any other state in 2012 with 6,082. Florida with 4,110 thefts, was second. Texas (3,400), North Carolina

(2,574) and Indiana (2,334) complete the top five states.

Looking at the cities where motorcycle thefts were reported, New York, N.Y., was at the top of the list with 903 thefts. In second place was Las Vegas, Nev., with 757. San Diego, Calif., was third with 633. The fourth spot was held by Indianapolis, Ind., with 584 and in fifth was Miami, Fla., with 535.

While the recovery rate for motor vehicle thefts in 2012 was 53.9 percent, for motorcycles in that same year it was only 39 percent. If not quickly recovered, stolen motorcycles are often “chopped” and resold for parts. Others are kept intact and resold to unsuspecting buyers after attempts to alter their identification. Still others are hidden away for years and, on occasion, recovered as they are headed for export in shipping containers.

At the Port of Los Angeles recently, a 1953 Triumph motorcycle stolen more than 46 years ago from Omaha, Neb., was found in a shipping container destined for Japan. Officers with U.S. Customs and Border Protection Service at the port sought help from the NICB in

tracking down the theft record that led to the original theft report taken by Omaha police in February 1967. From the theft record, the original owner was found still living in Omaha.

## Wheelies turn motorcycle wheels into TV screens

The latest in mobile bling can turn motorcycle wheels into TV screens by displaying static and streaming media content on the wheels of motorcycles and automobiles.

The technology has the potential to turn essentially any wheel in the world into a brilliant, full color billboard or video screen.

For advertisers, this could extend brand exposure with a flashier version of flat graphics that are common on the sides of cars and vans.

RYNO Motors announced that the company would start to accept customer deposits for the RYNO, a one-wheeled electric microcycle.

The self-balancing electric RYNO is designed for city errands, commuting to work and for personal transportation within large campuses and industrial facilities where people need to move quickly and efficiently over short to medium distances. The RYNO is small enough to be brought into offices and elevators, and it mingles well with pedestrians.

“The RYNO is a fun, efficient and convenient way to get from place to place,” said Chris Hoffmann, CEO and founder of RYNO Motors. “It’s half the bike and twice the fun.”

To operate a RYNO, the rider must balance the RYNO from side to side in the same way as any other bicycle, but the forward and back balance is managed by the electronics on the vehicle.

With a top speed of 10 miles per hour, the RYNO is suited for use in bike lanes and on sidewalks. It produces zero emissions, is easily charged in a normal AC outlet and costs under a penny a mile to ride. According to the company, initial pricing is expected to be \$5,295 per cycle.

The RYNO has garnered a lot of attention among consumers and media since the company began designing the product.

### Destination Dealership: Des Plaines Honda

To this day, Des Plaines Honda still ranks customer satisfaction as priority No. 1 and makes a concerted effort to give everyone who walks through the dealership an experience.

Des Plaines Honda was founded in 1983 by the Sondag family. Claude and Diane Sondag put in their time growing the dealership, and even in the business' early days, they focused on selling experiences. The Sondag family grew the dealership through marketing to the touring crowd and becoming the premiere Honda Goldwing dealer in the Chicago market. McLennan was a part of the Sondag team throughout the '90s and saw the dealership grow to be one of the largest Goldwing dealerships in Chicago, and in the Midwest.

Learning from the Sondag family, McLennan and avid motorcyclist Harry Pacynski



purchased the regionally known dealership. "We put forth a strong effort in making the purchasing experience fun and exciting," said McLennan. "We all must recognize that we are selling a want, not a need."



Des Plaines Honda takes advantage of its regional presence by staying very well connected with the local community. "Des Plaines

Honda believes you need to be involved in your community and local motorcycle community," said McLennan. "We have supported our community by

purchasing, servicing and training the police department on ATVs. We'll also send a representative each month to our local motorcycle clubs and have a presentation for them."

These are just a few of the things that the dealership does for its community. Des Plaines Honda also runs

a "Customer of the Month" article on its website highlighting a customer, their bike and a few personal riding stories. Des Plaines also sponsors



numerous charities such as the Muscular Dystrophy Association, Pediatric Brain Tumor Association and Ronald McDonald House, as well as individuals like Damian Jigalov, a local 8-year old who recently won the 2013 road-racing championship in his class. Jigalov will move on to the WERA Circuit in 2014.

The dealership holds in-store events, such as new rider classes, service clinics, ladies nights, an annual Christmas party and more. "Events like these have driven our fourth quarter sales up over 10 percent year by year since 2011," said McLennan.

Des Plaines Honda reaches national buyers as well. Because the dealership is located just five miles from the O'Hare airport, customers will fly in and ride home from there. "Chicago is an international hub, and we've seen an increase over the past few years in people who purchase a motorcycle to ride the country and sell it back to us three months later," said McLennan. "It's created a nice flow of late model used motorcycles for us."

This past June, Des Plaines Honda celebrated its 30-year anniversary. "We're proud of that accomplishment," said McLennan.

Des Plaines Honda is still growing, and new and used sales is just one of the ways that the dealership turns a profit. The dealership has a strong service department and even an award-winning finance department. No matter what though, Des Plaines Honda puts customers first and in return, customers are loyal to the dealership! And....That's what it's all about!


