Planning for '09 Elections

Officers, Directors, and members of Topcats, start making your plans for the Board of Directors, Committee Chairs, and participation in committees for 2009. If you're not running, get current on who is or who you think should be on the next Board.

Each year the offices of President, Vice-President, Treasurer and Secretary are open; those positions are for one year and the incumbent can stand for election a second term. Only two one-year consecutive terms are available in the "executive" offices.

Directors are elected for two-year terms and may run for two consecutive terms for a total of four (4) years.

If you are an incumbent and plan to retain your office, be mindful of the limitations. In addition, incumbents may run for a post other than one occupies and forfeit any remaining time if applicable.

Regardless if there is an incumbent who qualifies for a second one-year or two-year term, any regular member in good standing may submit an application to run for office. Said application can be written or phoned in to the committee of Past Presidents via Chuck Prettyman. (E-mail chuck.prettyman@att.net or 847-854-5929)

In the past few elections we have gotten away from the practice of past presidents selecting a slate from applicants and nominees and presenting that slate to the Board of Directors. The slate should be the result of interviews and discussions with the applicants and a consensus among the past presidents that the applicant is the most qualified of the candidates for a given office. One can imagine the

difficulty in getting a consensus with past presidents recusing themselves since they may be a candidate for office, and other past presidents taking a non-participatory role. Since the committee of past presidents sits at the pleasure of the President, it is the option of the sitting President to elect to have a slate versus a list of candidates.

<u>Members</u>: At this time, those members who wish to hold an office in 2009 should give due consideration and request to be included as a candidate.

A regular member in good standing is paid up and has had a pulse for one year since joining Topcats. A qualified candidate, however, has been active, attends meetings, participates as a chairperson or member of an ongoing committee, and is willing to put in the effort and work with fellow Topcats.

<u>Timetabl</u>e: All names to be submitted by the September 2, 2008 general meeting.

Interviews will be during the month of September. Submission of candidates names to the Board of Directors will be

October 8, 2008 pending the schedule of the meeting of the Board.

Candidates names will be published for the November ROAR.

Elections will be at the December general meeting.

Re: Absentee ballots: Those wishing to submit an absentee ballot must make application and receive instructions from the committee of Past Presidents.

General Meeting Minutes...

July 1, 2008

Gay Brandt (President) called the meeting to order at 7:35 PM.

New guests were introduced at the meeting. Ron, Keith and Jeff were all introduced. Also Jerry Milligan, a guest of Greg Smith's and Lisa, a guest of Ric Case were introduced as well as Larry's son, Patrick who was home on leave from his duties in Irag.

Gary spoke about the next elections for club officers and directors. Now is the time for all who want to consider running for office or chairing a committee for next year. This is your opportunity to lead and contribute in supporting your club. See any of the current officers and directors if you have any questions. Elections will be held in November.

Eileen Perry (Membership Director) announced that Robert Rafetto is a new Top Cat member. Unfortunately, he was not present to accept his membership handouts.

Don Shaffer announced new road captains; Eric Schertz and Brian Rainey. Both have passed all requirements to be a road captain this year. Both led rides in June. Brian's ride was to the New Glarus Brewing Company in Wisconsin and Eric's ride was to Fair Oaks Farm in Indiana. Congratulations to our new Top Cats road captains!

Don Shaffer presented our meeting's safety tip. Don asked for vol-

unteers to step forward with air gauges to measure the air in a spare tire. The results ranged from 29 to 33 lbs. Not all tire gauges measure properly but in this example the range was not bad. Inexpensive and miscalibrated gauges can cause an incorrect reading in your tire pressure. Be careful and verify your gauges results.

Don also talked to us about the differences in tire wear with improper inflation and how that can affect you. You can prematurely wear out your tire with improper inflation. Always follow your motorcycle manufacturers recommended tire pressure. Improper inflation is unsafe. How long your tires last depends on the tire make, type of motorcycle and your driving style and habits.

Greg Smith (Activities Director) presented future activities:

- July 4th, the Great River Road ride to Trempealeau, WI. This is an overnight ride 2 nights and 3 days for the holiday weekend.
- July 13th, the Progressive Dinner ride. The ride has been pre-rode and is ready to run. Wayne Kirkpatrick is hosting the first stop for a light breakfast. Eileen Perry is hosting the second stop for lunch and the final stop for desert is at Eric Schertz and Linda Zimmer's house. Cost is \$10 per person and guests are in-

vited.

- July 27th, the Ride for Dreams. All members should help by selling raffle tickets and being involved. It is important to sell as many raffle tickets as you can. A sign-up for setup help is being passed during the meeting. Volunteers are to meet at 9:00 am on July 26th.
- August 3rd, the Wisconsin State Fair ride. Mike Bradbury (Secretary) told the meeting that this is nice ride through Wisconsin backroads to the Fair. We will park on private properties near the admission gate with more than 3 hours to have lunch and see the fair. They have agriculture, rides, etc. and all should be home by dinner.
- August 10^{th,} the Mendota Sweet corn festival is new and was just added to the schedule.

Jillian from the Northern Illinois Special Recreation Association spoke on behalf of the Ride for Dreams. Jillian is involved with fundraising and told us that our donations go directly to aid with transportation, scholarships and Special Olympic costs. Loud Pipes Save Nothing

I'm going to take on a subject that may not endear me to my fellow Top Cats, but you all know that I'm not inclined to try to please everyone. Recent crackdowns on aftermarket mufflers in Lake Geneva and Kenosha County have cause a lot of riders to complain that their rights are being trampled. If this were still the days when a few hardy souls followed the two wheel pursuit of happiness, I might agree that there is not a problem. However, when thousands of riders pass down thousands of populated roads daily, we need to think about whose rights are being stepped upon.

Has it ever occurred to anyone that many aftermarket pipes really are obnoxiously loud, pollute the air more than 20 cages, disturb people deep in sleep, cause dogs to howl and cows to stop giving milk (Lots of cows being milked in Kenosha County)? To be a bit more serious, we have bought our own problems by going overboard with the volume of our pipes and when we open up the throttle to say "Look at Me". Now we are stuck with the consequences.

This is no different than what we went through with our hot rod cars in the 1950's. Every kid on the street was putting on an exhaust cutout. Anyone remember those? Pull a knob and the cutout butterfly rerouted the exhaust from muffler to straight pipe. Made your Straight 6 Plymouth pussycat sound like a moonshiner's tricked out V8 on Thunder Road. A few runs up and down the streets and the cops got complaints, started enforcing muffler laws, and convinced the legislators to pass even stricter laws with stiff fines and confiscation of vehicles. Who won, the hot rodders or the complainers?

The complainers, of course, because they were right. My home town of Memphis passed the strictest exhaust noise ordinances and inspection procedures in the country. Those who had switched to mufflers that gave just a bit more growl had to pull them and go back to stock to stay out of jail. Yes, a lot of little guys who manufactured trick headers, mufflers, etc went out of business, just like motorcycle suppliers are going to experience now.

Stop and think of how the world would sound if the

same percentage of cars as motorcycles were driving with open pipes. We would all be deaf. There are only a few reasons that can be given for running loud pipes. Getting a few more horse power by opening up the intake and exhaust certainly works, but if you want more power you can get a bigger or more efficient engine. You can't add enough Stage kits to a Road King engine to get it up to the power of a stock V-Rod. Cars have had to make the Power vs Noise vs Pollution choice for decades, and have come up with great compromises.

The "Loud Pipes Save Lives" line is really shaky. Bikes have horns to honk at stupid drivers, and by the time you are close enough alongside a cage for the driver to hear your pipes, you are already dead if he pulls into you. I guess that comes down to the "Look at Me" factor, which is certainly attractive to riders who want to be noticed, but isn't that why we have a problem?

How many attempts to write discriminatory laws against motorcycles would there be if all bikes were running stock mufflers? Nowhere near as many. The complaint and excuse for the laws are almost ALWAYS noise, except for the few against doing wheelies on Edens Expressway. The AMA figured this out a long time ago. Fighting the noise battle may cause us to lose the right to ride and encourage the legislators who want to regulate us into following the Common Market rules on everything from mufflers to knee armor.

I must close with proper disclosures. Yes, I ride a Gold Wing that is quieter than a stock Vespa 50cc. Yes, my previous ride was NAD with a Dutch Bypass in place of the catalytic converter, but with stock mufflers. Yes, my old VT1100 had Cobra pipes that growled a bit. I enjoyed making some noise and turning heads, but I have grown out of it. That may make me sound like an old guy who just cruises around on a bike, but isn't a real "Rider". I think not. None of my friends accuse me of riding too slowly, leaning too little, or failing to enjoy the pure power sports aspects of riding. Maybe I've just come to the realization that if we want to keep riding, we have to infringing on the rights of non-riders.



SAFETY... by Mark Heller



Well, I'm not on the safety committee but no-one turned in a safety article this month so I thought I'd share a personal experience with you to fill in the safety article's space.

This happened to me sometime in the mid to late 70's but I've never forgotten it. I consider myself lucky to be here today...I almost became a statistic.

I was living in Mt. prospect at the time, had been riding for about 3 years and I was riding the biggest bike I ever had...a Moto Guzzi 850 Eldorado. The Moto Guzzi in the mid 70's was a big bike, a touring machine not like today's Guzzi sport bikes.

I was southbound on Plum grove Rd in I believe Palatine approaching what I believe was Euclid ave. I was very familiar with the area, rode around there many a times. I couldn't tell you how many times I rode southbound through that intersection which I knew was a 2-way stop.

I knew that Euclid for eastbound and Euclid for westbound had stop signs and I knew that the southbound and northbound Plum grove Rd traffic had no traffic controls at all.

On this day I'm approaching the intersection with Euclid doing the usual 45 mph. A larg truck was stopped along the curb, facing southbound, just before the intersection.

I'm cruising along and getting closer and closer to the intersection. There was absolutely nothing different that day than any other day...so I thought.

I'm not sure how close I was in feet to Euclid but I was just about on top of it. As I approached the intersection at a good clip I saw that a northbound car had been slowing and coming to a stop. Then suddenly I saw it...sparking in the sun. It was the backside of a shiny new stop sign. I saw the backside of the sign for the traffic going the opposite way...the backside of the newly posted northbound stop sign.

My eyes immediately scanned right and I caught a glimpse of the new stop sign for the southbound traffic that had been obscured by the truck.

My eyes scanned left again and I saw the westbound car on Euclid begin to roll forward and enter the intersection. I applied my brakes; I really applied my brakes. I remember asking myself in the few seconds I had if I should lay it down.

There was no time to think. I remember realizing that I would never clear the intersection. If I entered the intersection I would be hit on my left side. I had a death grip on the handlebars and the nose on the bike took a dive as the tires squealed to a stop.

When the bike came to a stop, it was just barley into the intersection. The bike was upright and leaning far over to the left. I don't know how I managed to keep it upright, this was a very heavy bike for me and it was leaning over pretty far.

I remember that I was trembling and that I couldn't move right away. I remember sitting in the intersection for a while with cars honking and driving around me.

After a minute I moved my bike down the street and sat and collected my thoughts before moving on.

I thought I knew the intersection because I had rode through it on numerous occasions. The new stop sign was blocked by a parked truck. I wasn't prepared and it almost cost me.

It's just one more thing to look out for when you're riding...as if there wasn't already enough to look out for. Don't let your guard down.
