Top Cats General Meeting, September 2nd

The meeting was called to order at 7:40 PM.

One guest, Brian, was introduced to the club.

The Top Cats club picnic was held recently at Morraine Hills State Park. Thanks were given to Mike Bradbury who organized it, Terry Kumro and Cindy Raybern for all their work to make it happen, and Lenny Innocenzi for his hamburger donations from his restaurant, Buffos in Highwood Park. The picnic had food, games, and activities including water balloons provided by Muriel Brandt which were a nice way to cool off during the hot and sunny summer weather. The picnic was a good time and will be held again in 2009.

Chuck Prettyman, Past President and head of the Elections Committee, is soliciting candidates to fill positions for 2009. The executive positions to be filled for 2009 are President, Vice President, Treasurer and Secretary which are held for only 1 year and can only be filled by the same person for 2 consecutive years. One Director position is open too.

Thanks and appreciation was given to Tom Nichols, our chair-person for the Ride for Dreams and all who assisted with the ride. Tom and others, giving their time and efforts ,made this year's event happen and with everyone's help, enabled the Top Cats to donate \$8,500 this year to N.I.S.R.A.

Eileen Perry and Joan Durango are holding a meeting for anyone who wants to help or has ideas for next years charity ride on September 9th at Gino's East located on Highway 22 in Lake Zurich.

Come to discuss the ride with your ideas and ways to keep it good and make it better.

Gary Brandt (President) presented a check from the Ride for Dreams for \$8,500 to Brian Shahinian from N.I.S.R.A.

Brian thanked Top Cats for this year's \$8,500 donation. Top cats have given \$210,000 in total donations from the club over the past 11 years. Our donation is used in 3 ways. 1/3 goes to scholarships. N.I.S.R.A. provides scholarships to 71 out of 229 participants in their programs. 1/3 goes to the transportation fund. N.I.S.R.A. recently was able to replace their 15 seat van for a safer vehicle. And the last 1/3 goes to staffing. N.I.S.R.A.

serves 13 communities and Brian said they are very appreciative of our support.

Eileen Perry (Membership Director) announced 4 new Top Cat members since the last meeting. Paul and Jill Hansen, Mary Walters and Pat Michaud are all new members. Eileen presented Pat with her new membership flag and patch.

Greg Smith (Activities Director) announced future activities.

road captain. This is a ride to Monroe Wisconsin and the Green County Cheese Festival. This is an all day ride of about 200 miles. Lunch is at the fair. Bring your cooler bags in case you want to buy some cheese.

The ride is a colorful tree lined route to a lunch in Northern Walworth County of Wisconsin and will return to the start point at approximately by 3:30 PM.

Ric Case presented our meeting Safety Tip(s). We all must be extra careful traveling at night. Bouncing lights in front of you indicate bumpy roads ahead. Eyes reflecting from your head lights indicate wild life is in your path. Lower your speed to a

walking pace and be wary. Chasing dogs will triangulate on your position so slowing down will disrupt them. There are 3 types of shoulders we encounter beside the road. They are blacktop, grass, and gravel. Be aware and be prepared. Crowned roads are better turning to the right then left. When turning left your lean angle is eliminated, so slow down. Rick also offered that traveling by interstate highway can be safer because you avoid the intersections in local travel. Watch for beat up cars. They may loose parts and they also tell you that the driver is careless in their driving style. Avoid driving in a truck's blind spot. Be visible.

Don Shaffer added that trailer trucks have an extra blind spot in the front from the truck up to 20 feet ahead of it.

The floor was opened to member comments.

The accident scene management course is open again and is being held sometime during the 3rd week of October. An email will be sent out with information.

The next G.R.A.S.S. class is being held on Sunday, November, 9th.

The meeting adjourned at 8:35 PM.

SAFETY...

Sooner or later you are going to wonder about how to handle severe crosswinds – probably while fighting them. Surprise, surprise – you don't have to do anything and the motorcycle will handle most crosswinds just fine – with only normal responses from you.


There are a couple of things that you can do to make the experience less stressful, however. For example, you can quit white-knuckling your grips. When you hold on tight you also tend to stiff arm your controls. That, as we've talked about before, merely allows front-end instability to propagate into the rest of the motorcycle. Relax you grips and droop your elbows. Allow your bike to be a bit unstable. Drive in the CENTER OF YOUR LANE. Lean forward and down to reduce your profile, and snug up your jacket.

What about traction? You neither gain nor lose any significant traction when the wind blows from your side unless you are in a curve. While you are leaning into the wind, all of the weight of the bike remains on your tires (fancy that) and there is very little lateral force scrubbing that traction away.

How much lean do you need? Whatever the bike dials in for you. Should you anticipate those gusts? Should you just respond quickly to a gust in order to remain in control and continue traveling in a straight line? No, and no. Your bike will NOT travel in a straight line. That is as long as you allow it to do its thing. Your bike will be modestly blown off course with a gust and the results of that movement is EXACTLY the same as any other minor course change. You will need modest counter-steer input to correct it – the CG (center of gravity) of your bike will then be on the side from which the wind came and the result is that it will lean towards the wind.

Anticipating wind-sheer IS important under a couple of scenarios: the approach of an oncoming large vehicle suggests that severe buffeting will occur when you pass it, and entering or exiting stretches protected from the wind such as tunnels or bridges with relatively high retaining walls. In these cases you will certainly want to position the bike away from the source of the wind-sheer and insure you maintain a firm grip.)

Is a heavier bike less likely to be blown around than a lighter bike? No necessarily. What is primarily determinant of how great the effect of a crosswind will be on your bike is its profile. Baggers and Goldwings are typically more harshly affected by crosswinds than a lighter, low profile bike.



Can you mitigate some of that instability in any way? Yes. There are cowling additions that can be designed (some are available off the shelf – called "belly pans') that streamline the airflow under your bike and help (modestly) reduce crosswind handling problems.

Your side profile area is what determines how your motorcycle reacts to crosswinds. Just as there is a Center of Gravity, there is also a Center of Wind Resistance. If that Center of Wind Resistance is in front of your Center of Gravity, crosswinds will tend to push you off course, while if it is behind you Center of Gravity the motorcycle will try to steer INTO the wind. Therefore, mounting a high profile LIGHT object (a stuffed animal, for example) onto your trunk lid or your pillion can have a dramatically corrective effect rather than worsen the bike's steering reaction to those crosswinds.

Crosswinds can be murder if you are leaning way over in a curve. Don't, if you can avoid it.

As a result of a crosswind, your bike will move off course and normal modest, counter-steer will lean it into the wind. A strong gust will blow you out of track. So, correct your steering, gently, and keep going...

I admit that sometimes a gust can be ferocious! I was on the bridge at Chamberlain, South Dakota in the rain once when a crosswind blew me into the adjacent lane! But the bike was in no danger of falling down and it was easy to get back in lane. Had the gust been a sustained blast I would have been leaned over nearly 45 degrees. It was not sustained, thankfully.

Note...there are TWO times when a gusty crosswind changes your bike's direction of travel: when it hits, and when it stops. Both require that you allow the bike to respond and use normal, modest counter-steering. (When it quits you will be leaned over and, as a result, your bike will move towards where the wind WAS coming from until you straighten up.

If crosswinds involve huge short gusts, go park the bike. If the crosswinds are moving and sustained, pucker up and keep going.
