

General Meeting Minutes... October 7, 2008

Gary Brandt, (President) called the meeting to order at 7:35 PM.

The following guests were introduced to the meeting; Jeff Smith from City Limits Harley Davidson, Kevin Smith who has been at a meeting before and Bill Lowry. Also introduced by Dennis Dougherty were Jan Wilcox and introduced by Pat Machaud was Larry Tyma.

Some storage bins containing club material were water damaged recently at the Village Bar and Grill where we store them. Gary offered "slightly damaged" first aid kits for only \$5.

Club dues are the same for 2009 as they were for 2008. Membership will be releasing new information soon. Dues for regular members are \$75, for associate members \$65 and for family membership \$125. Please pay promptly.

Ed and Sue Apel have generously donated a Kendon two rail motorcycle trailer to Top Cats to be sold / auctioned with the proceed to be donated to NISRA. Joan DeRango, (Charity Ride Committee) presented the committee's progress and ideas developed so far for next year's event. A list of ideas was handed out that was generated from their last meeting. The committee is seeking help and ideas for the 2009 event. Leaders are needed to take charge for the different functions of the event such as the raffle, advertising and promotion, flyers and posters, registration, the ride itself, food, the silent auction, vendors, entertainment and corporate sponsorship. Already Tom Malia has volunteered to lead and manage the ride itself. Other road captain volunteers to lead groups are needed.

A lot can be generated for the Charity ride from early registration. This is helpful too in case the weather is poor and the "ride in" turnout is low.

John Lunde, (Safety Committee) presented the meeting's safety tip. Riders should look at their general health at the end of the riding season the same as we do maintenance checks of our motorcycles. Eyesight, hearing, and overall general physical status including a stress test should all be checked and done. We all need to take care of our bodies in order to ride safely.

Winter is a good time of the year for purchasing accessories and gear. With the Cycle World International Motorcycle Show in February and other events and promotions, this is a good time to get deals and save money.

No general comments were given.

The meeting adjourned at 8:30 PM.

I collect and archive all photos from members, and manage and upload the photos that appear on the Top Cats website. I have also provided content and presentation material for G.R.A.S.S. Class and Road Captain training. I participate in almost all Top Cats rides and monthly meetings except those when I am either out of town or unable to attend due to family or business commitments.

2) Most Favorable Part of Being a Top Cat

Like most of you, I was attracted to the Top Cats by the quality of the members, their passion for sharing the road with fellow motorcycle enthusiasts, their obsession for promoting safe riding, and being with a great group of people with a predisposition for having fun.

We have a lot we can do to make the club better, stronger, and more robust. Everyone should get engaged and support the club in some way, big or small.

4) Proposed Improvements and Changes to the Club

I see the Top Cats as an elite group of riders. We differentiate ourselves from other clubs by our professional membership profile, highest standards for safe riding, and commitment to each other as both friends and riding colleagues. We continue to be a strong club, but there are things we can do to help improve it, insure the club's legacy, and clearly communicate our identity.

Balance Core Values and Traditions with Change and New Traditions

Over the years we have established some traditions that are at the core of our culture. As we continue to evolve we must remain true to those traditions while at the same time embracing change. It is not an easy task and sometimes hard to let go. I would propose our theme for 2009 to be 'Back to the Future'. We need to find the right balance between old and new that will encourage growth and change yet preserve our core values and culture. We need to put personal biases aside and work together to create what is best overall for the club, now and into the future.

Market and Promote the Club More Aggressively

We are now a club of over 100 members. How big should we become? As we create a vision for the future, we should set some guidelines for how big we want to be and put an aggressive membership campaign in place to bring new members into the club. Some ideas include:

• Assign members to become Top Cats Ambassadors to targeted clubs and organizations to promote the Top Cats as well as exchange ride and event information. This is done somewhat ad hoc today. We should formalize it.

• Attract members that clearly meet the club membership criteria. We are an elite group of riders and professionals. We need to continue in that tradition and invite only those into the club who meet the established criteria maintaining the elite distinction without arrogance.

Use the annual banquet as the premier kickoff event for the riding season. Hold the event in March prior to the kickoff ride. Have the officers and board present the 2009 plan in addition to the past year's awards. Invite potential new members, alumni, lapsed members, and possibly key members of other clubs and preferred vendors.

Reengage our Alumni and 'Lapsed' Members

Why is it that people leave the club.... life changes, lost interest? Why do people lose interest? What can we do to keep people engaged and create a compelling environment for members to feel a void if they don't participate in an event. Let's actively reach out to our alumni and lapsed members and find out why they are no longer active and find ways to reengage them. They are all part of our tradition and heritage.

Create Additional 'Value' for Our Members

As part of further extending our reach into the motorcycle community and attracting members, we should find ways to create additional value for our members. Some examples include:

- Assign members to keep the online calendar updated as the 'most comprehensive' list of motorcycle events in the area. Who knows, it may even draw people to our website... and the club.
- Implement a Top Cats Preferred Vendor Program establishing preferred relationships with a few key suppliers of motorcycle and riding products and services. In exchange for discounts for Top Cats, they can be provided a small ad space for free in ROAR and possibly our web site.
- Continue to bring in a guest speaker at all Top Cats meetings. Create an annual list of topics, solicit speakers, and publish the monthly speaker list on the website.
- Create an annual editorial calendar for ROAR. Line up writers and content well in advance. Invite outside contributors... publish ROAR on time.
- Continue our tradition of great ride experiences. We had some great new rides this year. All the members
 and Road Captains need to continue to come up with new and innovative rides, events, and motorcycle experiences.

'Ruthlessly' Promote Motorcycle Safety and 'Walk the Talk'

The Top Cats are passionate about safety and safe riding. This is not only a very good thing for the members, but also a key opportunity for the club to differentiate ourselves from other clubs and a great way to attract new members. Wayne Kirkpatrick recently was asked to put on a G.R.A.S.S class for the Combat Veterans of America, in Ohio. There were over 35 attendees from the east coast. We should continue to upgrade our G.R.A.S.S. curriculum and presentations, and seek ways to align ourselves with other safety organizations and present G.R.A.S.S. to other motorcycle clubs and at dealers to help promote the Top Cats.

We have about 25 Road Captains in the club... almost 25% of our membership. We have very specific ride protocols that we ask all members to follow. As a Road Captain, nothing is more frustrating for me than to see Top Cats members not passing hand signals up/back, not maintaining our ride formation spacing, or violating some other protocol. While we want everyone to relax and have a good time, the Top Cats ride protocols are proven and are for our personal safety. They need to be followed by everyone. Almost as important is for every member to set a good example of ride safety for new members and guests. All members need to closely follow the protocols to the very best that they can on each and every ride.

Road Captains need to hold each other to the highest standards. The RCs are responsible for safety. They need to be diligent in doing detailed and complete ride briefings each and every time, no matter how experienced the riders, and follow our ride protocols to the letter. Members and guests have the right to expect con

sistency and only the best from our ride leaders.

Some of these ideas may have been tried in the past. If they weren't successful then we need to find out why, fix them, or come up with new ones. Safety Article by Bard Boand

Here is to looking up your rear view mirror....

Tailgaters drive me crazy! Are you one of those who are right on my ass or in my blind spot? Are you on or in someone else's?

If the 1 second / 2 second spacing rules doesn't work for you, or you are challenged by math, here is an easy technique you can use. It works for me.

1/ Locate the rear view mirror of the bike to your right or left in front of you. That means to your oblique front, or aprox. 20 degrees front right or front left.

2/ Can you see the riders eye balls or sun glasses? Or do you see blue sky?

3/ If you see his eyes / glasses, you are probably one second behind him exactly where you should be. A bonus: he / she can see you.

4/ If you see blue sky, you are either too close or too far behind.

5/ This only works if his / her mirror is properly adjusted, so always adjust your mirror once out on the road way.

6/ If you still feel too close, or too far behind due to improper mirror adjustment of the bike to your front oblique, go back to the one / two second rule you learned in GRASS or MSF Class.

7/ Additional safe spacing distances may vary due to weather or road conditions.
