# Board Meeting Minutes

January 13, 2009

Board Members Present: Carl Marcyan, Mike Bradbury, Tom Nichols, Joan DeRango, Dennis Dougherty, Wayne Kirkpatrick, Eileen Perry, Greg Smith and Gary Brandt

Board Members Absent: None

Guests: Tom Malia, John LaMonica, Andy Konsewicz

Meeting was called to order by President Carl Marcyan at 7:21 PM.

## Minutes

Process for approving General and Board Meeting minutes were amended as follows:

- General Meeting minutes will be circulated to all Board members prior to the board meeting. Review and approval of the General Meeting Minutes will occur at the first board meeting following the General Meeting.
- Board Meeting minutes will be circulated via email to the board members for review and approval.

Minutes for both meetings will be reviewed and approved within a week of each meeting in order to make the article submission deadline for the ROAR.

## Historian for the club

Carl suggested the club record the club's history- how Top Cats started, what being a member stands for, who were the charter members, a profile of our current membership, etc.

The board will seek out a member to investigate and recommend a plan for obtaining, recording and updating the clubs history.

Dennis will create a want ad for a Club Historian to be posted in this month's ROAR.

Dennis volunteered to be the Board Liaison to the club's historian position. He also volunteered to assist with the pictorial history.

## Committee Accountability

Each of the clubs committees will be expected to establish specific goals, both objective and subjective for 2009, submit them to the board for approval. The committees will provide written updates on their progress towards meeting the established goals.

- The Safety Committee's goals have already been established and approved by the board.
- The Charity Ride Committee has established goals and objectives for '09. The goals will be submitted for approval at the next board meeting.

The Membership Committee needs to establish and submit goals.

## Membership Dues

Eileen reported that membership payment is slow. Over half of the membership has yet to pay their '09 dues.

An email notification will be sent to members who have not yet paid.

- Gary will assist Eileen in preparing and sending the late notice/payment request via email.

- Tom Nichols will investigate utilizing Quick Books next year to create invoices and track payments. Eileen will write an article for ROAR reviewing the guidelines for the timely payment of membership dues.

## **Growth**

Carl recommended utilizing the general meeting as a means of providing guests with membership information and to have a more visible presence at the meetings. The board agreed.

Eileen will investigate options for printing Top Cats brochures to be available to guests at general meetings.

A table will be set up at the entrance of the general meeting room. There will be a guest sign in and nametags as well as material (i.e. the brochure and membership forms) for guest to take.

The table will also have Top Cats products – T-shirts, decals, flags, etc.

Eileen will create a schedule for manning of the table at each meeting. Initially the schedule will have board members greeting guests with the hope that eventually other Top Cats members will volunteer to assist.

## **Misc.**

Cindy Raybern has volunteered to assist Eileen with membership related tasks.

Motion was made by Mike Bradbury granting board members the authority to spend up to \$200.00 per year on club/committee related purchases without obtaining board approval. Gary Brandt seconded them motion. All members were in favor – no one was opposed – the motion passed.

Membership information (address, phone, email etc.) will continue to be distributed to other members on an “upon request” basis only.

## **Products**

Currently Top Cats’ products are retained by a number of different members. Greg Smith has approx. 8 T-shirts, Eileen Perry has flags, patches and pins, Gary Brandt has decals, and Mike Bradbury has some small flags. Carl recommended all products be consolidated and retained by one individual. Wayne informed the group that Top Cats previously had a board appointed Sergeant at Arms position. Setting up the room for general meetings and retaining club products were part of this position’s responsibilities. A discussion followed regarding whether or not the club needed to invest in more products such as shirts and patches for members to purchase.

Tom Nichols will create a survey for the membership to help the board determine the product related needs/wants of our members.

Carl will provide Mike Bradbury with names of local vendors to survey for product purchase options. Mike will report his findings to the board at the next meeting

Carl will prepare an article/ad for the ROAR informing the membership the board is seeking volunteers for the Sergeant at Arms position.

Mike Bradbury will merge current products and will retain them until the Sergeant at Arms position is filled.

Greg Smith will check with the people who created the logo for our current shirts to see if they are able to identify the font (pronounced “fount”) used.

## **Recognition Patches & Pins**

Wayne will prepare a recommendation for the board on ways to use patches and pins to recognize members by the next board meeting.

## **ROAR**

Carl asked John and Andy to update the board on issues they have experienced with publishing the ROAR every month. The biggest issue has been getting members to write articles and submit them timely. Although there have been problems in the past in being able to quickly turn around an article to meet the ROAR deadline Andy and John have worked out most of those issues and are able to accommodate last minute “important” articles. Jill Hansen has volunteered to assist with editing but equipment conflicts (Jill has a MAC) have made it difficult. Members have expressed a desire to continue to receive a notification and/or the actual publication via email. SPAM blockers have made it difficult to effectively send the notification/publication.

Gary will insure Road Captains adhere to the article schedule and submit pertinent articles timely.

John will create a schedule assigning each board member a month in which they will be responsible for authoring an article. Gary will be assigned October for election information.

Carl will provide Andy with information on a service utilized by his company to send quarterly newsletters so Andy can investigate the costs of using the service to send the ROAR to all members.

Dennis committed to having any photos provided by members up on the FTP site within a week of their receipt.

John will remain the ROAR editor for the remainder of '09 mentoring Jill on the position and evaluating her ability to take over as editor next year.

Dennis will investigate the possibility/feasibility of utilizing the G.R.A.S.S. computer for ROAR.

## **Website**

Carl requested an assessment of the status of the club's website. Gary explained that Brian Rainey completed all the “technical” website updates the club has asked him to complete. Ongoing technical support though is sporadic due in part to Brian being the only person able to complete additional technical design and his limited availability. Gary is able to update the day to day items such as the calendar, articles or new links. The board agreed that we need to utilize our website better and to do that need to be able to have technical updates performed with greater consistency.

- Andy Konsewicz and Dennis Dougherty volunteered to research viable options and report back to the board in 60 days.

Dennis will be the board's liaison for the website project.

## **Financial**

Tom Nichols reported that the club's current balance is \$8,659.00 not including membership dues received last month.

- Tom will work with B of A to change the account information to remove Tom Malia and add Tom Nichols as the club's treasurer.
- Tom will prepare the 2009 budget to be presented at the next board meeting.



## **Safety**

Wayne reported the next G.R.A.S.S. class will be held on 3/15/09. Three Road Captains have already volunteered to teach the class. Due to recent issues with the management at the Village Green Wayne is investigating an alternate/back-up location to for the class and potentially the club's general meeting. Docks in Wauconda was suggested as a possibility. Dennis will investigate Dock's as an alternative and report back at the next board meeting.

## **Awards Dinner**

Mike presented the board with the agenda for the Awards Dinner. (a copy of the agenda will be retained with the minutes). Dennis is creating the slide show for the event. Don Shaffer will bring the projector for the slide show, Millrose will provide the screen. Current responses total 33; 17 short of the minimum of 50 required. Mike informed the board that it will be more cost effective to pay Millrose the \$200.00 for not making the minimum instead of purchasing 17 additional meals. The final count is due to Millrose on Wednesday, January 17<sup>th</sup>. Mike will send a final email to members that have not responded as a final effort to reach out to all members.

## **Activities**

Greg Smith reported that Pat Machaud has volunteered to join the Activities Committee. She will take responsibility for the Hot Line and the publicizing its existence to all members. Greg informed the group that the ride calendar is filling but slowly. The committee has set a goal of 30 rides for this year. 2008 total was 22.

## **Charity Ride**

Joan DeRango reported that the Charity Ride Committee met again on Thursday January 8<sup>th</sup>. The ride flyer is currently out to committee members for approval. Plans have been made to have Larry Scallzitti distribute flyers at the Chicago Motorcycle Show at the end of January. Mike Bradbury and Jeff Tietz are compiling a list of events where we plan on promoting and selling raffle tickets. The committee will be looking for volunteers to attend the events. In some cases it will be necessary to find someone to tow the scooter to the event. The next meeting will be held in February at Frank Colletto's house. Between meeting the committee members work on assigned tasks and keep each other updated vial email. All Charity Ride updates will be communicated at each general meeting, through emails to the membership and in ROAR articles.

With no further business to discuss the meeting adjourned at 9:15 PM.

So, it seems to me that a practice session should be stressful if we are trying to gain skill levels and should be satisfying if we are only confirming a skill level.

I usually find that I am totally drenched with sweat and dead tired after only 15 minutes of a good practice. But far more often than not a practice session for me lasts only 5 minutes and I am content that it has been perfectly sufficient for my purposes.

When I practice I am always looking for the little secret that makes what I am attempting look easy. That is, riding a motorcycle is not at all difficult. Riding it with complete control, on the other hand, takes skill and experience. The experience exposes those 'secrets' (that slow speed control, for example, is fundamentally in your left hand) to you and practice provides the experience in a relatively safe environment. Once you learn them they look to others like you have 'skill' while in reality what you have is confidence. Over-confidence, on the other hand, means only that you THINK you have the skills you will need. Using practice to confirm your skill level is the difference.

All I'm trying to get at is that when you start out, or come back after lots of years being away from motorcycles, or upgrade to a heavier or different type of motorcycle, your skill level is nonexistent so practice MUST increase them as you 'stretch/grow'. And the process of growth (confidence building) is stressful.

When you are tired, or notice that you are not making progress in one skill area or another, go for something else or call it quits for the day and go home and park the beast. Next time you go out and practice you will more likely than not do better on your first try than you did on your last one the last time out. And the stress level will diminish.

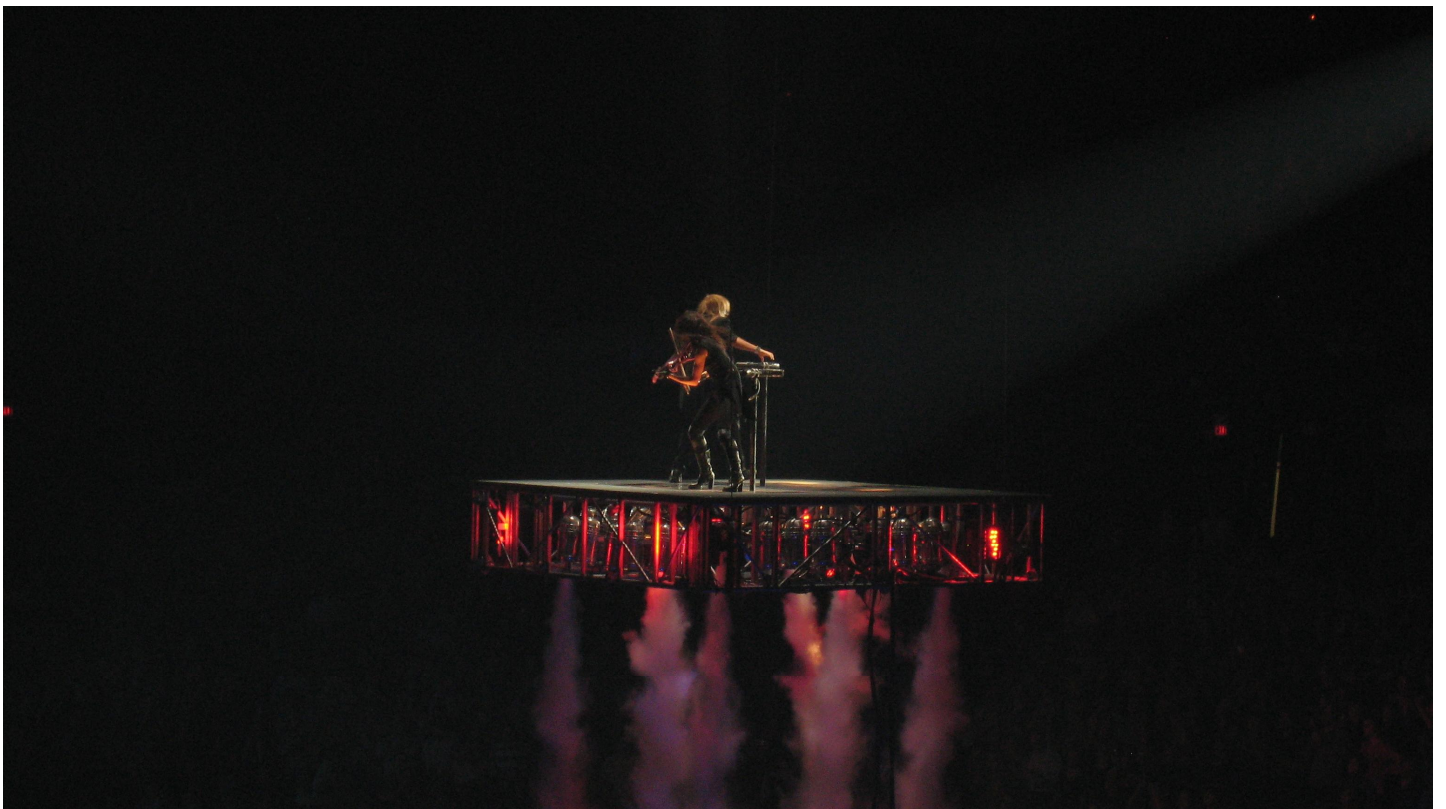
Don't feel like you are the only person that goes through it. After 45 years of riding I am often stressed when I practice. That's good, no? It means that I really am trying to get better at something that I'm not at all confident about. Toes over the line - with successful effort - results in moving the line. And that's the primary reason we are out there.

In the end, being on the road should not be stressful at all because you have enough experience that you KNOW you can control your bike, not just react to what it does on its own. That's confidence.

Sooner or later you will realize that you can always improve some aspect of your skills but you will CHOOSE not to. That is, your practice sessions will be used to confirm that you can always do AT LEAST as well at something as you elect to be your personal target. That turns a practice event into a pretty short session if all is well. If not, you get back to the level you personally insist is how good you want to be.

Stress is associated with getting better, not with confirming you 'still have it.'

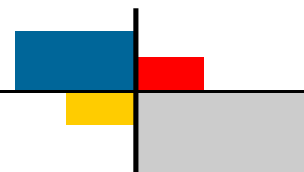
