# **KAUTION KORNER**

#### **TIPS FOR THOSE WHO RIDE IN THE RAIN INTENTIONALLY OR NOT** by Chuck Prettyman

"If you never have and never will (ride in the rain) consider selling your bike" Copied from Bob Sgarlata

Nobody's an expert, and everyone has some good tidbits to share. Here are some of them:

Of the variety of rain gear we have to choose from, Harley Davidson keeps us dry and visible. In addition, it's Colorful! The Orange and black stands out in the rain and at night. The hood attachment covers the neck and part of the face (if you want) and prevents rain going down your neck. Mine has lasted three seasons. The Negative of the Harley gear: It's not cheap.

There is also Top Gear apparel, which is lighter in weight and easier to store. They have a bright yellow jacket for safety, but it was found that the jacket's waterproofing broke down after a few years. The camouflage version which is all black and construction grade, did not meet the criteria for SAFELY keeping one dry while riding a motorcycle in the rain.

### Some tips to remember while planning for the rain:

 Get GOOD rain gear. It has to be compact when folded, relatively easy to get on, and it should cover every part that you want to stay dry. Practice putting it on while on the side of the road with your helmet and boots on - yes, seriously.
Wax your windshield. Don't use RAINX - it will fog plastic.

3. Wax your helmet visor (if you use a full face) Waterproof boots (I have the ALPINESTAR with Gore-Tex and they're great!)

Next, remember that once it starts raining the first 30 minutes are the most dangerous. This is when oil rises from the crevices and cracks in the road from the water (it's lighter than water). If you can, that's the best time to stop for a coffee/bathroom break...give it a good 30 minutes to let the oil run off the side of the road.

Another consideration: WATCH WHERE YOU PUT YOUR FEET DOWN. One can step in a water-oil mix and slip or in a hole filled with water.

Finally: Use common sense. Slow down a bit. Allow for longer braking distance. Use BOTH brakes simultaneously. If you skid with the rear brake, HOLD IT UNTIL YOU STOP...front brakes, you have to let the wheel turn or you're going down!

### Bob also recommends these few last things to keep in mind:

1.) Keep your rain gear in the right side saddlebag. This is not only the 'high bag' when the bike is on the kickstand - making it easier to access, it is the side of the bike away from traffic - keeping the bike between you and cars zooming by in poor visibility.

2.) Put your flashers on when you are pulled over putting the rain gear on.

3.) You can often tell when you are about to ride into a storm - so stop while it has yet to rain - or just drizzling. And put your rain gear on then instead of waiting to do so in a pouring thunderstorm.

Take care! Ride safe!

**Technology That Can Impact Your Life** 

### WELCOME TO THE ENCHANTING WORLD OF WEBCAMS

Webcams (short for World Wide Web cameras) have been around for more than a decade, but today they're easier than ever to use. For video conversations, each party must have a computer that came with a webcam, or buy a webcam that can be plugged into a computer.

You also need a high-speed Internet connection (otherwise the video and audio will be choppy) and a computer with speakers. Both parties must also subscribe to a service that makes the connection. The leading services are Skype (<u>www.skype.com</u>), which can be used on both PCs and Macs, and iChat (<u>www.apple.com/macosx/features/ichat.html</u>), which is for Macs. Another up and coming company to offer free as well as a premium service is Oovoo at <u>www.oovoo.com</u>. These services are free, as are most of the other popular ones, including Yahoo! Messenger, AOL Instant Messenger and Windows Live Messenger.

Once you sign up on the Web for a webcam service, you can make video calls to people who subscribe to the same service or to a compatible one. If the services aren't compatible, it's usually easy to sign up for the same service used by the person you want to call. (You can sign up for more than one webcam service.)

To make a call, you first use your computer to access your video phone service. Then enter the user name of the person you want to speak with. The service sends that person a message that there's an incoming call. Once the person signs in, you'll see his/her image on your screen, and that person will see yours -- and you can start talking.

**Another wise move:** Give a webcam to friends and family members with whom you'd like to keep in touch. Young people will often be excited (if not impressed) by such a tech-savvy gift. **Caution:** Don't give a webcam to a child or grandchild without consulting their parents. There are many pornography sites on the Internet that prey on children with webcams.

When you shop for a webcam, look for one with...

• A built-in microphone, a feature that most webcams have.

•A clamp to attach the webcam to your computer monitor, a stand on which the webcam can also be placed and a cord that's more than two feet long. These three items make it easy to put the camera in a variety of positions, depending on the type of conversation you plan to hold. To speak face-to-face with one person, for example, you might put the webcam directly in front of you, clamped to the monitor. On the other hand, if you and your spouse are part of the conversation, a long cord and a stand will let you set the webcam several feet away on your desk so you both will be in the picture.

Popular webcams include...

**Logitech QuickCam Pro 9000,** which has wide-angle focusing, high-quality images and a built-in microphone. *List price:* \$99.99. *Information:* Visit www.logitech.com/index.cfm/webcam\_communications/webcams/.

**Microsoft LifeCam VX-3000**, which comes with a built-in microphone but has somewhat lowerquality images. *List price:* \$39.95. *Information:* Visit <u>www.microsoft.com/hardware/digitalcommunication/ProductDetails.aspx?pid=001</u>. (Other Microsoft webcams -- still under \$100 -- have higher-quality images.)

*Webcam setup:* All you have to do is plug it into your computer and install the software from a disc that comes with the webcam. Many retailers can also help by sending a technician to your home or by advising you via phone or computer. Depending on what type of webcam assistance you need, these services might cost \$100 to \$250.

*Very shrewd move:* Find out if friends or neighbors use webcams. If they do, ask them to help with any setup problems you may run into.

#### Webcams for Safety

The versatility of webcams has recently led to their use for home safety. *Example:* For Mac computers, *Periscope* is software that lets your webcam take pictures of any home intruders when you are not at home.


The program automatically switches on the camera as soon as it detects sound or motion in a room. Periscope then takes pictures that are uploaded to the manufacturer's Web site. That way, intruders can't destroy the pictures, even in the unlikely event that they discover the webcam, which is usually in an inconspicuous place, such as a cluttered bookshelf. *List price:* \$24.95. *Information:* 212-929-3549, www.freeverse.com/mac/product/?id=7002.

*Mugshot* is a similar program that enables a webcam to sense motion and photograph intruders. It then sends you their pictures via e-mail. *List price:* \$8. *Information:* <u>www.nimisis.com/projects/mugshot.php</u>.

These "intruder cams" don't replace burglar alarms, but can be useful additions, providing police with evidence that can lead to arrest and prosecution.





Tollway, is being closely monitored, and not just from the peace officer in the squad car. The State of Illinois has now installed static radar detector units on the Tollway and monitors cell phone signals as well as I-PASS transponders to check for speeders, among other things. So far, the Illinois State Police is not allowed to issue tickets from these but has been given jurisdiction over all these modes and dispatches troopers to areas of speeding abuse. The next step, of course, is automatic ticketing. Our local communities will get on the band wagon once they realize they can supplement revenue. As you know, local government has installed countless red light cameras that generate big bucks. The companies that sell this equipment do not charge for it but take a piece of the action every time the hapless motorist pays a fine. The Chicago Tribune has already made expose of politicians' relatives and friends that are owners of these "traffic monitoring" equipment suppliers who are feathering their nests with our hard earned income.

Do not just sit back and accept this. Contact your State Representative and local governmental officials and complain. Email, snail mail ... anything to get their attention that they have stepped over the line. Protect your rights, liberty and independence.


#### Activities-Larry Scalzitti/Greg Smith

Proposed marking up Top Cat merchandise to cover handling costs. Carl Marcyan motioned and Dennis Dougherty seconded the motion. The board approved.


