Traveler's Top Ten Tips for Twenty-Twelve First Edition...

By Traveler, of course...



Ten survival tips. Why only ten? I have a variety of over 50 safety tips that I have stashed away over decades of riding and, now seems like the time to start sharing them with as many riders as possible...ten at a time. Some of these, I realized, were actually dated from the late '60s. But, as you'll see, they are still relevant, topical, and wise advice for us to follow regardless of age, experience, or skill levels.

1. Always assume that you are **invisible**. Never assume that drivers see you.

2. Be **considerate**. Never ride so aggressively that it antagonizes other drivers. Remember, the right – of way belongs to the vehicle with the most lug nuts and motorcycles have none.

3. Dress for the crash not for the prom or the fashion show. Your protective riding gear should be **functional** first and fashionable second.

4. Ride like a pessimist. Anticipate the **worst case** event at every intersection, every passing situation, every turn, every curve and....plan on your evasive / corrective action.

5. Leave your **ego** home. Never take it with you on a solo ride or a group ride. An ego can be a horrible co-rider.

6. Stay **alert**, alert, and alert. Scan ahead, scan behind, never get too comfortable and start day dreaming.

7. Mirrors only say "No!" Your **mirrors** will show you a vehicle overtaking you but, they must not be relied on to clear a lane before making a lane change. Always clear the lane by

looking first.

8. **Search** for and avoid; big potholes, road debris, oil spots, semi – trailers, dump trucks and mini vans.

9. Use **both** front and rear **brakes** together. Two brakes will stop you, one brake will just reduce your injuries a bit.

10. **Never trust** deer whistles, a GPS, a fuel reserve light, a can of fix – a – flat, or a left turning, on – coming vehicle.

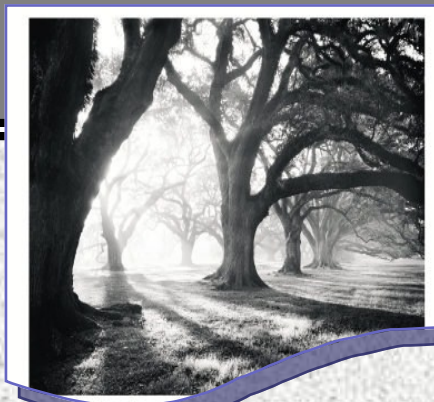


Finally, old, grey – beard, riders, don't get that way by riding **stupid**. They get that way by riding **smarter** than the traffic around them.



Being afraid of your own shadow....

...is not considered to be a positive attribute of one's personality. But, being concerned about *someone else's* shadow can enhance your chances of reducing risk and riding your motorcycle more safely.

Last Friday (January 6th) I could not resist the temptation of the full sun and 53 degree northern Illinois temperatures to once again pull the cover off the Road King and hit the back roads of Illinois "*one last time*" this winter. I imagined my bike moaning "really, are we going out in the cold *again?*"

Zigging and zagging north and west on back roads from where I live on Countryside Lake, I find myself in McHenry County at the intersection of Johnsburg Road and Route 31 braking for a fresh red light. I decide to zig north (to my right) on Route 31, so after stopping and not seeing any traffic approaching from the south I pull onto northbound 31. My routing is somewhat dictated by the map display on my GPS, so even though I am not following a programmed route, I am still using the display as a map. I routinely find myself zooming the screen shot in and out as I make decisions on where I will turn next. The more zoomed in the screen, the more details (roads, businesses, landmarks) it displays.

I sheepishly admit I am probably "fiddling" a little too much with my GPS (translation – distracted driving) as I head north, and am subsequently not driving with my rear view mirrors like I should be.

However, the position of the GPS is adjacent to the left side rear view mirror, so my peripheral vision picks up anything in the mirror.

About a mile north of Johnsburg Road I decide I will make a left hand turn onto Barnard Mill Road, which I am rapidly approaching in about a quarter of a mile, to ride through the small town of Ringwood. Ringwood was originally settled by a small group of families from Vermont in 1837. It now has a population of 836 and is the home of *Rohm & Haas*, a Dow Chemical Company subsidiary, *Huntsman International*, a global manufacturer and marketer of chemicals, and international thermal technology company *Modine Manufacturing*.

As I make the decision this sunny day to signal the left turn I see a split second image in my left rear view mirror of what appears to be a shadow on the blacktop immediately behind me. It's not unusual for large birds, or low flying airplanes to cast a brief moving shadow like that onto the pavement. What I do not anticipate, after a check of both mirrors and side to side movement in the lane, is to be startled by some idiot on a blue and white colored rice burning crotch rocket about 50 feet behind me! (my apologies, so as not to offend; ... an uninformed, speeding, young person, riding a high powered, light weight, sport bike type motorcycle, manufactured on the continent of Asia). I quickly activate my left turn signal along with an arm signal, earlier than I normally would, and initiate my turn onto Barnard Mill Road as he zips past me in the right side of my lane.

Riding along thinking no other vehicles were anywhere near me, had I not acted on the subtle clue provided by the shadow and conducted a rearward search, I may have executed my quickly approaching left turn just as this fear no evil, speeding silo of testosterone could have passed me on the left where we no doubt would have had the unfortunate meeting of the metal!

As this incident proves out, bad things usually happen fast, and being constantly aware of what's happening all around you in your "bubble" will greatly increase your personal safety and the *enjoyability factor* of every ride.

YOUR SOURCE FOR UPCOMING ENTERTAINMENT AND EVENTS

Ah, spring! With the passing of March 1st, we have now entered meteorological spring, March 1st to May 31st, which means warmer weather is just around the corner. This season brings increasing daylight, warming temperatures, and the rebirth of flora and fauna and another riding season!

The true season of “spring” begins in the Northern Hemisphere on March 20, 2012, at 12:14 A.M. (CDT) with the vernal equinox.

The word equinox is derived from the Latin words meaning “equal night.” The spring and fall equinoxes are the only dates with equal daylight and dark as the sun crosses the celestial equator. At the equinoxes, the tilt of Earth relative to the Sun is zero, which means that Earth’s axis neither points toward nor away from the Sun.

Now for the bad news, according to Matt Friedlein, Meteorologist at the National Weather Service, looking ahead, the entire Midwest region will likely see both above-average temperatures and heavier precipitation in the next three months, according to the models. It will be wetter and more mild than normal.

One reason the Chicago area has experienced such a mild winter season is that the region is experiencing positive phases of a large-scale phenomenon known as the North Atlantic Oscillation and the Arctic Oscillation. This is the movement of the cold air pool as it resides over the North Pole that tends to slide South over North America, Greenland or Europe. This year the oscillation fell over Europe causing the extreme heavy snows and colder temperatures in that part of the world. The past two winters here at home have experienced atmospheric pressure trends mostly in the negative phase, leading to the extreme cold and heavier snow in the past.

Let’s all hope that the weather patterns provide for beautiful weekends and the heavier precipitation occurring during the week... Only time will tell.

Turnout has been tremendous at the past non-riding events and it appears that the comradery of this club is alive and well; however the month of March is quiet for club activities...

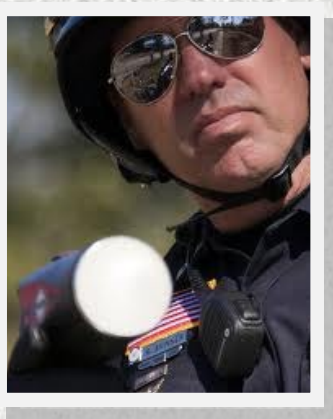

CONGRESS MOVES TO ABOLISH MOTORCYCLE-ONLY CHECKPOINTS

Motorcycle-only checkpoints have revved up concern in Congress. Wording was recently inserted into the House highway bill that would bar the U.S. Department of Transportation from providing grants to local governments for such discriminatory inspections.

The action arose over motorcycle-exclusive roadblocks set up in Georgia and New York under federal safety grants that single out motorcycles for police to check the bike and rider for proper paperwork, helmet, exhaust and equipment violations.



Rep. Jim Sensenbrenner (R-WI), who sponsored H.R. 904 to ban federal funding of motorcycle-only checkpoints, applauded the House Transportation and Infrastructure Committee saying: "It is encouraging to see that the transportation reauthorization bill will encourage more efficient use of taxpayer dollars and smart motorcycle safety policy."

"Motorcycle riders are right to be outraged at being singled out for safety inspections," added Rep Tom Petri (R-WI). "Nobody is suggesting flagging cars down for unscheduled inspections, and there's no good reason why motorcycles should be treated differently. It's unnecessarily intrusive, and not a smart way to use limited police resources."

Section 5007 of H.R. 7, the "American Energy and Infrastructure Jobs Act of 2012" reads:

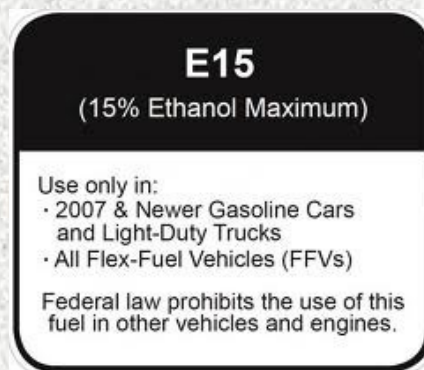
PROHIBITION ON FUNDS TO CHECK HELMET USAGE OR CREATE CHECKPOINTS FOR A MOTORCYCLE DRIVER OR PASSENGER.

The Secretary may not provide a grant or otherwise make available funding to a State, Indian tribe, county, municipality, or other local government to be used for any program to check helmet usage or create checkpoints for a motorcycle driver or passenger.

The House bill will now go to the full House floor before going to the Senate for consideration. The Senate will consider their own version of the highway bill, and a final version will be ironed out in a conference committee.

HOUSE COMMITTEE SEEKS FURTHER STUDY OF ETHANOL-BLENDED GAS

The House Committee on Science, Space and Technology passed H.R. 3199 on Feb. 7th to require a comprehensive study of the implications of ethanol-blended gasoline.



Although the Environmental Protection Agency approved E-15 (15% ethanol fuel) in October 2010 for use in most cars, it is not approved for any motorcycles and the hotter-burning formulation can cause premature wear and could void manufacturers' warranties.

The bill, introduced by committee Vice Chairman Rep. Jim Sensenbrenner (R-WI), would require the EPA to seek independent scientific analysis on the effects of E15 gasoline on engines.



VIRGINIA MAY LEGALIZE TWO-ABREAST RIDING

The Virginia General Assembly is considering the repeal of a 40-plus year-old law that makes it against the law for two motorcyclists to ride side-by-side in the same lane.

Virginia and Vermont are the only two states in the U.S. with such a law on the books, while 48 other states either don't ban the practice or have specific laws allowing it. There's no indication those states have more crashes or problems related to two-abreast riding, according to the Virginia Coalition of Motorcyclists.



The law is an old one, possibly sparked by the menacing image of motorcycle gangs of the 60s. But since the law was passed over four decades ago, motorcycle registrations have shot up and charitable motorcyclists now ride in large groups for fund-raisers or to raise awareness, when riding two-deep is common.

FLORIDA SEEKS STIFFER PENALTIES FOR NEGLIGENT DRIVERS

ABATE Florida members from around the state were out in full force at the state capitol on Feb. 13th asking lawmakers for safer roads and to support legislation for stricter penalties for drivers who kill bikers on the road.

"Kill a motorcyclist they get an \$82 fine, that's all they get; failure to yield. You do that in a car, hit somebody else in a car, you get vehicular manslaughter," said James "Doc" Reichenbach, ABATE President.



Reichenbach, who also serves as Chairman of the Board for the National Coalition of Motorcyclists (NCOM), testified on behalf of ABATE's Stiffer Penalties Bill, S.B. 1754, which passed the Senate Transportation Committee on Jan. 27th by a vote of 7-0, and now goes to the Senate Criminal Justice Committee.

During the rally in Tallahassee, the names of bikers killed in wrecks last year were read aloud. Fifty-six bell chimes were sounded; one for each lost life. The bikers spent the rest of the day talking to lawmakers, then headed home hoping when they return next year, there are fewer bells to ring and fewer bikers lost.

MYRTLE BEACH RALLY CONFUSION PROMPTS ABATE BOYCOTT

Myrtle Beach Harley-Davidson has moved the dates of its official spring rally into late May, effectively adding 10 more days of Harley-related events on the Grand Strand Rally and sparking confusion among bikers, businesses and rally promoters over when the rally will take place.

Horry County (S.C.) ABATE has decided to stage a boycott, not of the spring bike rally, but of the local Harley dealerships involved in rescheduling the Cruisin' the Coast rally to May 18-28, carrying it over into Memorial Weekend when sportbikers traditionally begin arriving for Atlantic Beach Bike Fest aka "Black Bike Week".

"The dust just got settled with Horry County, and now this has upset the county council all over again," said Gary Balcom, ABATE chapter coordinator, recalling that in 2008 Myrtle Beach passed a litany of laws aimed at ending the rallies altogether, including a city-wide helmet law that was later ruled unconstitutional. "It's a bad idea and was not discussed with anyone else," said Balcom.

He told me he would be at the Chicago Speedway at the Nascar races this Memorial Day weekend premiering his skills as a race car driver. Russ is an engineering technician who analyzes what problems occur when Nox sensors are not performing properly. They are the sensors that are instrumental in making diesel engines work. At what point in your life did you decide to move into the world of motorcycle riding?

How long have you been riding?

"Ten years. I've also completed the MSF experienced rider course."

What do you most enjoy about motorcycle riding?

"I find it is the best escape from everyday responsibilities. The feeling of freedom and wind in your face is a de-stressor for me."

What is the most interesting place you have been while riding your motorcycle? Why is this your choice?

"One place comes to mind and that is Sedona, Arizona. The scenery was beautiful and very peaceful. Although we had hoped to make it up to the mountains near Flagstaff, the weather was prohibitive and we decided not to make

the trek at the time. There's always tomorrow!"

Do you have an item or lucky charm that you never go riding without?

What is one interesting fact about you or your life that most people may not know?

About 7 years ago my wife, Theresa, suggested that I go in for a colonoscopy because of a family history of colon cancer. While I hesitated, she persisted that I make an appointment and go forward with it. The surgeon found the polyp and had a biopsy done. It came back malignant. They removed it and I did not have to have chemo. I am 7 years cancer free now.

If you could give one tip to a rookie motorcycle rider, what would it be?

Take your time and enjoy the ride. Relax, rejuvenate, clear your mind. That's what it's all about.

We now have learned a little more about our newer members of Top Cats, Russ and Theresa Peiffer...

It is now time to meet one of our older, er, more experienced riders. One of the Founding Fathers of Top Cats... Ladies and gentlemen, Bard Boand is in the house!

I had the pleasure of interviewing Bard for this article recently while he sat in his living room in Carefree, Arizona gazing at the mountains in the distance and enjoying the 74 degree temps. That is to say, HE was gazing at the mountains in the balmy temps. I was in my office in Rolling Meadows, Illinois gazing at a dreary sky and trying to keep warm in 32 degree weather!

One of the things that came to mind while speaking to Bard was the phrase, "Still waters run deep." His life and motorcycle adventures far surpass what most mortals have dreamed of much less actually done. He is no stranger to the roads less traveled. Although now retired, he still spends as much time as he can on his motorcycle while also living life to the fullest.

Here are some of the highlights of my conversation with him:

What is your occupation? What previous career choices have you made?

"I have 34 years with the Flying Tigers and Fedex in international sales and management. The Flying Tigers were known as World War 11 famous fighter pilots, then, started an all-cargo airline in 1972. In 1979, Fedex bought them out and I retired in 2005."

At what point in your life did you decide to move into the world of motorcycle riding and why?

"In 1967, my first year of college, I started riding Triumph 500's. At the time, it was the cheapest and most fun transportation."

How long have you been riding? What motorcycle accomplishments or awards have you achieved?

"I've been riding for 45 years and have various licenses and Top Cats awards." In 2006, I rode with the GlobeRiders around the world for 3 1/2 months. They are an Ad-

venture Touring group and we traveled through Siberia, Inner Mongolia, Russia, and parts of Poland. One incident stands out in my mind about that trip. While we were in Russia, there were cows standing all along the roads. One of them decided he did not like our disturbance in the peaceful surroundings, and started to chase after a rider. It actually kept pace with the motorcycle until he overtook the rider and crashed head-on into him and his bike! The rider was fine, but the bike was totaled. Lo and behold, a group of Russians came down the road in a truck and put the bike in the back and drove the man to a location where they hand tool iron parts. The hospitality of the Russian people in such a remote place was unbelievable. They opened up their shop and tried to remake parts for the bike so that the gentleman could continue his journey. I also found that of all the cities I have been in, I would have to vote Krakow, Poland as the best. Its culture, beautiful sights, wonderful people, and the cosmopolitan feel makes one feel that they have been transferred back in time. Yet the city has a very modern feel to it."

What do you enjoy most about motorcycle riding?

"The feeling of freedom that comes when you are traveling on two wheels. The sights, sounds, and smells that accompany the ride. Also, having the ability to explore remote places in a way that allows those very things."

DO you have an item or lucky charm that you never ride without?

"I always carry a Sacajawia one dollar coin with me. Sacajawia was an Indian guide for Lewis & Clark. The U.S. minted a \$ coin about 10 years ago. In Asian countries when someone does you a good turn, you give them a gift. So, I took a roll of these coins with me. When people were cordial to me, I gave them a dollar as repayment. Also, a Kennedy .50 cent piece would also be significant to give as favors in remembrance of the agreement Krushchev and Kennedy came to during the Cold War. Something the Russian people really found memorable.

This was the question I was most interested in asking him:

But there are other concerns, too, Balcom said. The large crowd would overwhelm local law enforcement resources, he wrote in an ABATE statement. "The last thing we want to see is any event getting out of hand," Balcom wrote.

The statement calls the date change "a slap in the face to the county council" and encourages bikers to boycott the two dealerships in Myrtle Beach and North Myrtle Beach "and we hope that the biker community as a whole will come together with us on this boycott until such time as they retract their plan of overlapping dates."

WORLD-FIRST STUDY ON CAUSE OF SERIOUS MOTORCYCLE ACCIDENTS

A world-first study will examine the cause of serious motorbike crashes. Motorcyclists will be part of a \$1.3 million Australian study aimed at slashing the number of motorcycle accidents. The ground-breaking inquiry will compare the experiences of riders injured in crashes at specific sites with riders who have travelled through the same site safely.

Transport Minister Terry Mulder described the new research as one of the most comprehensive motorbike studies attempted globally. "By comparing the two groups, we hope to learn not only what went wrong for those involved in crashes, but also what went right for those who negotiated a particular crash site safely," Mulder said.

More than 1100 riders - half of whom have survived crashes - will be recruited over the next 18 months.

Experts, five of whom are motorcyclists themselves, will analyze factors such as speed, experience and the physical environment in accidents. Results are expected towards the end of 2013.

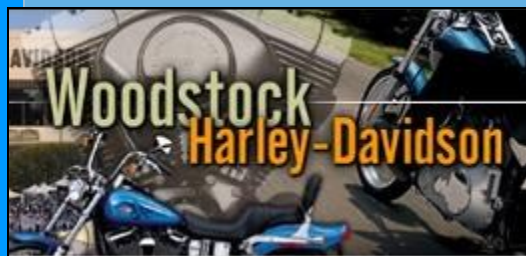
