Autumn Leaves The Beauty and the Beast

Fall has arrived and will soon award us with its beautiful colors. There may be no better way to experience these colors than riding a motorcycle on the open roads. Fall also starts the winding down of our riding season and at the same time, gives us some of our best and most colorful scenic rides.

As the leaves start showing there vibrant colors they also start to fall, blow around, and pile up. This piling up of leaves happens not only on our lawns and driveways, but also on the roads causing multiple road hazards. This is the Beast side of fall that we must endure.

We may assume that wet leaves offer less traction than dry leaves; this might be true. The real question is how dry are the leaves. Leaves hold moisture and as they start to decay they generate more moisture. The leaves on the top of a patch or pile may appear to be dry and blowing around. However the leaves underneath, on the road surface, may be wet and starting to decay causing very slippery oil like conditions. This condition can be very dangerous especially when stopping, accelerating and cornering. When riding you would always do your best to avoid oil on the road. Likewise, you should do your best to avoid leaves.



Another serious condition caused by falling leaves is the covering and camouflaging of road hazards. What may appear to be a small pile of leaves may not be a pile at all but in fact a few leaves covering an obstruction on the road such as a rock, stick, or chunk of asphalt. Patches of leaves may also cover other serious road obstructions such as potholes,

large cracks, and uneven road surfaces. All of these serious obstructions could cause you to lose control of your motorcycle.



The best thing to do while enjoying all the beauty of a fall ride is to make an effort to avoid riding through those tempting piles and patches of leaves.

Enjoy the fall, ride safe, and get out there and see those beautiful colors!

"The regulator/rectifier can overheat and prevent the motorcycle from charging," NHTSA said in Recall No. 12V445000. "Once the battery is fully discharged, the motorcycle may stall." Unexpected stalling increases the risk of a crash, the agency reported.

Dealers will be required to inspect the units and, if necessary, replace the regulator/rectifier free of charge. Triumph said it would notify owners directly but did not specify when that effort would begin.

Harley Diagnostic iPhone App

A Canadian software designer has developed an iPhone app that helps diagnose mechanical problems on Harley-Davidsons with an easy-to-read digital gauge. GaugeFace designer Sven Resch created the app for Harley-Davidson models, but he said he's working to expand it to other makes.

If you're apt to figure it out and you can clear the problem, you don't have to go to garage to do things, and if you bring it into a Harley shop, you can feel confident that things are on the up-and-up."



The app, compatible with iPhones and iPads, gives users a variety of displays including a speedometer, tachometer, levels for engine temperature, a fuel gauge, gear indicator and indicator lights. The software can be downloaded for free, and for \$265 users can also buy the hardware adapter, which connects the iPhone to a Harley-Davidson.

"It's really been popular more with the younger crowd, so what I'm finding is there's a cross-section News and Information) of those that are techno-savvy, that have an iPhone, are really into it, and they have a Harley-Davidson," Resch said. "I think that cross-section will expand

over time as the demographic of people buying Harleys slowly changes."

E15 Back In The News

The EPA approved E15 in October 2010 for use in cars from model years 2007 and later, then in January approved the fuel for use in models made from 2001 to 2006.

Last month, the US Court of Appeals dismissed a challenge of the EPA's authority to permit 15-percent ethanol (E15) content in gasoline for 2001 and newer model year cars and light trucks.

Plaintiffs in the case included groups representing the motorcycle industry. Judges David Sentelle and David Tatel found the concerns advanced by petitioners were primarily speculative and not based on any concrete, documented concerns on behalf of their representative client base. They ruled that the implementation of E15 was simply an option and not a government-mandated requirement being forced into the marketplace.

Qualifications, Nominations, Voting and Elections

Over the past 18 years, our Club has had the good **DIRECTOR QUALIFICATIONS**: fortune of being led by a group of dedicated and skilled Board members. They have initiated new programs and activities, established innovative processes, always tried to please as many as possible, kept our Club evolving and, on occasion, put in long hours, struggled with sensitive issues, and made tough, and thankless, decisions.



As we approach our elections this December, we have an obligation, as members, to continue that legacy of competence through our electoral process. By now, all members should be aware of our requirements for voting, our eligibility requirements for running for office, and our open Board positions and term lengths.

Now, in the very unlikely event that you forgot, here is a summary of our process and our policies....

OPEN BOARD POSITIONS:

This year, we will be voting on a new President, Vice President, and two directors. Each will start a new, two – year term on 1 Jan 2013.

OFFICER QUALIFICATIONS:

Candidates for President, Vice President, must have Ballot voting will be held at the 4 Dec 12 General three years as a Full member in good standing in the Club and have served as a committee chair or in a Board position, for one year.

Candidates for director must have a minimum of one year as a Full member in good standing and have served on a committee or in a Board position for one year.

TERM LENGTHS:

Officer and director terms are two – year terms, not to exceed three two - year terms.

ELECTION CYCLES:

The President, Vice President, and two directors will be elected this year to serve until elections for the 2015 term. In 2013, we will have elections for our Secretary, Treasurer, and two directors who will serve until elections for the 2016 term.

NOMINATING PROCESS:

Full Members, in good standing, may nominate any of the eligible individuals listed above for an open position. The names of nominees must be submitted to any Board member; (President: Wayne Kirkpatrick, Vice President: Gary Brandt, Secretary: Mary Walters, Treasurer: Stewart Johnson, Past President: Mike Bradbury, or directors: Larry Johnson, Ric Case, Ric Case, or Greg Smith) before 15 Nov 12. Members who nominate an individual should assure that the individual will accept that nomination. Candidates may be nominated anytime prior to 15 Nov 12 by email, telephone, or in person to the serving Board members. Nominees will then be verified as Full Members in good standing who accept the nomination and added to the ballot.

VOTING:

Meeting. To be eligible to vote members must be Full Members in good standing i.e. attend three Top Cats events during 2012, and 2013 dues paid.

- The idea of giving proceeds of product sails to NISRA was discussed. Dissent included the idea that we are infusing membership money with the charity money. Since there isn't much profit on these shirts, The Charity Committee will review the profit to see if it is worth the bookkeeping efforts. The discussion will be tabled for another time.
- Wayne asked that other ideas be developed to supplement the money that is collected during the year for NISRA.


