
Search and Ye Shall Find!

Whenever I teach a motorcycle class, there are a few key things that I want my students to remember for a very long time. When I first started teaching, I just assumed that everything I said was forever etched in stone in each student's memory. Since getting acquainted with reality, I now realize that no matter how often I say things or how energetically I teach, there will always be some concepts that students don't retain. The best I can expect is that each new rider walks away with some knowledge. More importantly, I hope that I've also instilled in my students the need to continue to learn and improve their skills. If these riders stay true to that wish, they will become not just lifelong learners, but they will treat each ride as an opportunity to become better riders. That continued reflection on skill development can excellent strategy for all riders: serve as the basis for constantly improving their ability to ride safely.

We've all heard these comments before:

"That idiot pulled out in front of me . . . " "I couldn't believe they stopped in the middle of the intersection . . . "

> "The turn didn't look that sharp . . . " "Where did that car come form . . ."

All of these and more can probably be avoided if we take a hard look at the incident without our egos leading the discussion. The Motorcycle Safety Foundation (MSF) Basic Rider Course (BRC) espouses an

<u>SEE – Search – Evaluate – Execute</u>.

In my mind there are three big things that every rider No magic here, the concept is pure common sense. should be well versed in. The first item is awareness It's just that easy to think through the road that lies

SEE. Courses that I've taught over the years have the rider searching anywhere from 12 to 20 seconds ahead. Well, just how far down the road is 20 seconds? Rather than struggle with speed related calculations, I think what everyone is trying to say is look down your path of travel as far as you can see and search for things that may cause you harm. If you can ger is on the other person or thing that put them in a do that and continue to look down the road aggressively, you won't be surprised.

In order to effectively search ahead you will need to place your bike in a position that allows you to see. Sometimes your vision of the road ahead may be blocked by a large vehicle. If you're on a multi-lane road, then change lanes and move past that vehicle to allow you to see ahead and regain your ability to search the entire area coming into view.

If you have but one lane to travel down, then increase your following distance, in order to open up space between you and the larger vehicle ahead. This will give you a better view of what lies before you. You should also change your position within the lane. Ride in the left track for awhile and then the right track. Vary your time in each track, scanning down the road ahead and try to build a complete picture, even though that large vehicle in front of you may be blocking the middle of the road. The more information you can gather and piece together about what's ahead, the better able you be able to spot and avoid trouble before it becomes a problem.

By changing tracks you also give the traffic that lays ahead of you a better chance of seeing you. As you ride in the left, then right track, and fall back from the vehicle in front, the oncoming traffic will be more roadway from any cross streets or driveways ahead.

Bottom line - Remember to choose your position on the road based on both your ability to see and vour ability to be seen by others.

You can also choose to make you and your ride easier to see. Since we're harder to see than cars, it becomes our duty to increase our visibility to others:


Wear brightly colored clothing. Lots of manufacturers have brightly colored gear for all kinds of riding conditions. You can also add a high visibility vest over your leather jacket to get more attention. Don't forget helmets, black look cool, but other colors will make you stand out rather than blend into the scenery. In the rain wear gear that has retro reflective materials. This is a great time of year to buy clothing. Last year's gear is still good and the

prices are slashed to clear remaining inventory. Check out one of my favorite places for deals – www.motorcyclegear.com

Ride with your high beam on during the day. It will help you stand out from the crowd of day time running lights. If you're riding a cruiser with a single headlight, you'll increase the life of your low beam filament. Also, I highly recommend adding additional lighting both fore and aft. The more visible you are, the more likely you'll be seen and the safer you'll be.

Brake lights. Remember that a flashing light attracts more attention than a steady one. If you're the last vehicle in line at a stoplight or stop sign, remember to be in first gear, keep an eye on your mirrors for fast approaching vehicles, have an escape path and pulse your brake lights as a vehicle approaches.

In the final analysis, when you're on your bike there is no one to blame but yourself. We need to be constantly looking for potential problems and we need to take action before those problems develop in order to eliminate or minimize them. The only way to do that is to be aware of everything coming towards you and likely spot you, especially those vehicles entering the to let everyone know you are there. Stay visible and remember to put yourself in the best possible position to see and to be seen. Ride safe!

DEER TAKE DEADLY TOLL ON

MOTORCYCLISTS!!!!!

Research by AAA that found that nationwide, about 70% of deer-crash fatalities involve motorcycles.



The deer mortality rate becomes most evident this time of year, (Nov - Dec) as the mating season has more deer on the move. Their carcasses by the roadside attest to the danger that the lure of romance poses for them and for drivers.

In 2010, the latest year for which there are national statistics, 403 people were killed in accidents involving deer.

MOTORCYCLE THEFTS DECLINE

The National Insurance Crime Bureau (NICB) reported that in 2011, motorcycle thefts in the United States were down 6 percent from their 2010 total. There were 46,667 motorcycles reported stolen in 2011 compared with 49,791 in 2010.

The theft rate averages out to one every 11 minutes. All data is from theft reports contained in the National Crime Information Center.

The top five makes stolen last year were:

- Honda, 11,014
- Yamaha, 8,880
- Suzuki, 7,281
- Kawasaki, 5,009 and

Harley-Davidson, 3,120

Combined, these five brands accounted for 35,304 thefts in 2011, or 75.6 percent of the total.



For 2011, the top five states with the most motorcycle thefts were:

- California, 5,927
- Texas, 3,950
- Florida, 3,927
- North Carolina, 2,466 and

Indiana, 2,114

These five states accounted for 18,384 thefts, or 39.3 percent of the total.

Of some significance is the fact that thefts were down in 2011 while motorcycle sales increased slightly from 2010. According to the Motorcycle Industry Council, motorcycle sales increased in 2011 to 440,899 units — up 0.3 percent from 439,678 units sold in 2010.

More than 500 motorcycle makes were among those stolen last year, but the highest percentage of bikes stolen were of the Honda brand, at 24%. Yamaha was next (19%), followed by Suzuki (16%), Kawasaki (11%) and Harley-Davidson (7%).

LEGAL BATTLES CONTINUE OVER MONGOLS CLUB COLORS

An unprecedented federal government effort to seize the Mongols Motorcycle Club's trademark has quietly become a quarter-of-a-million-dollar headache for the Justice Department, reports McClatchy Newspapers. Four years after prosecutors grabbed national headlines by seizing the Mongols' logo, an appellate court must now sort out what the federal government might owe the club's attorneys.

It could be a lot, in a free-speech case that's also a cautionary tale about aggressive federal use of forfeiture to seize private property. (Continued on page 5)

"What they did was an outrageous violation of the First Amendment, and an absolute abuse of forfeiture and trademark laws," American Civil Libration Hair and Libration Policies and Civil Libration Hair and Civil Libration

il Liberties Union attorney David Loy told the paper. Rebuking prosecutorial overreach, a federal judge in Los Angeles ordered the Justice Department to pay \$253,206 to Loy and Alan Mansfield, an attorney with Consumer Law Group of California, who successfully challenged the prosecutors' attempt to seize the Mongols' trademark.



Angeles-based prosecutors claimed a huge haul in October 2008 when they announced mass indictments of Mongols MC members, and in addition to physical assets such as motorcycles, firearms and other property, prosecutors sought to claim the Mongols' trademarked name and logo. "If any law enforcement officer sees a Mongol wearing his patch, he will be authorized to stop that gang

member and literally take the jacket right off his back," then-U.S. Attorney Thomas P. O'Brien declared at the time. But a judge in Los Angeles ruled last year that prosecutors had gone too far. The judge reasoned that the trademark belonged to the organization, not to individuals, and therefore unindicted club members should still enjoy the right to use it.

Last February, another federal judge added that the Justice Department had to pay for the trademark fight because the government "violated settled First Amendment and trademark law." "The novelty of the government's position did not make it substantially justified," U.S. District Judge David O. Carter ruled.

The Justice Department is appealing the judge's order to pay, however, with the 9th U.S. Circuit Court of Appeals likely to hear the case next year.

<u>PALESTINIANS CRACK DOWN ON</u> MOTORCYCLES

Lawmakers in Gaza have continued their draconian campaign against motorcycle usage, taking the bold step of banning the import of spare parts for motorcycles into the ancient Palestinian city.

Interior Ministry official Hassan Akashed has admitted that the move aims to directly reduce the number of motorcycles, which he claims are a main cause of car accidents.



According to visordown.com, motorcyclists in the city have been subject to an ongoing crack down, banning them from riding after midnight, and restricting women from riding. The Interior Ministry recently announced that it was banning women from riding bikes or being pillion passengers, to limit accidents and "protect community values."

Israel's blockade of Gaza has meant that parts for cars have been

impossible to get hold of and the cost of maintaining them has become unsustainable for most.

As a result, motorcycles have seen a huge surge in popularity. Just five years ago there were only about a dozen or so motorcycles in the city, but the number of motorcycles in Gaza had grown to around 15,000 by 2010.

EUROPEAN BIKERS PROTEST VEHICLE-INSPECTION PLAN

Thousands of motorcyclists rolled into Belgium to protest an EU proposal for regular mandatory bike inspections. The law would be "expensive and useless," said representatives from the Federation of European Motorcyclists' Association (FEMA) who met with European Union officials EU headquarters in Brussels as more than 4,500 motorcycles roared through the city's streets, protesting the proposed law that would introduce mandatory EU-wide road-worthiness tests for motorcycles.

Members of Belgium's Federation of Angry Bikers (FBMC) turned out in large numbers for the protest. "Only 0.3 percent of motorcycle accidents in Belgium and 0.6 percent in Europe are due to technical problems," FBMC head Joe Verrecke told the Belgian news agency Belga.

FIRE DAMAGES CHICAGO MOTORCYCLE SHOP

Authorities are investigating the cause of a Oct. 4 fire that caused an estimated \$110,000 in damages to a motorcycle shop in this town, roughly 40 miles west of Chicago. **Diesel's Service & Repair** sustained about \$50,000 in damages to 10 to 15 motorcycles, \$40,000 in losses of tools and equipment, and about \$20,000 in damage to the building, Acting Battalion Chief Scott Hogan told the <u>Bellingham *Herald*</u>.

Qualifications, Nominations, Voting and Elections

Over the past 18 years, our Club has had the good **DIRECTOR QUALIFICATIONS**: fortune of being led by a group of dedicated and skilled Board members. They have initiated new programs and activities, established innovative processes, always tried to please as many as possible, kept our Club evolving and, on occasion, put in long hours, struggled with sensitive issues, and made tough, and thankless, decisions.



As we approach our elections this December, we have an obligation, as members, to continue that legacy of competence through our electoral process. By now, all members should be aware of our requirements for voting, our eligibility requirements for running for office, and our open Board positions and term lengths.

Now, in the very unlikely event that you forgot, here is a summary of our process and our policies....

OPEN BOARD POSITIONS:

This year, we will be voting on a new President, Vice President, and two directors. Each will start a new, two – year term on 1 Jan 2013.

OFFICER QUALIFICATIONS:

Candidates for President, Vice President, must have Ballot voting will be held at the 4 Dec 12 General three years as a Full member in good standing in the Club and have served as a committee chair or in a Board position, for one year.

Candidates for director must have a minimum of one year as a Full member in good standing and have served on a committee or in a Board position for one year.

TERM LENGTHS:

Officer and director terms are two – year terms, not to exceed three two - year terms.

ELECTION CYCLES:

The President, Vice President, and two directors will be elected this year to serve until elections for the 2015 term. In 2013, we will have elections for our Secretary, Treasurer, and two directors who will serve until elections for the 2016 term.

NOMINATING PROCESS:

Full Members, in good standing, may nominate any of the eligible individuals listed above for an open position. The names of nominees must be submitted to any Board member; (President: Wayne Kirkpatrick, Vice President: Gary Brandt, Secretary: Mary Walters, Treasurer: Stewart Johnson, Past President: Mike Bradbury, or directors: Larry Johnson, Ric Case, Ric Case, or Greg Smith) before 15 Nov 12. Members who nominate an individual should assure that the individual will accept that nomination. Candidates may be nominated anytime prior to 15 Nov 12 by email, telephone, or in person to the serving Board members. Nominees will then be verified as Full Members in good standing who accept the nomination and added to the ballot.

VOTING:

Meeting. To be eligible to vote members must be Full Members in good standing i.e. attend three Top Cats events during 2012, and 2013 dues paid.


