KAUTION KORNER

Oh Deer! Ride Carefully!

To start this month's Kaution Korner discussion, I would like to add a couple of additional comments to last months KK article on ABS Breaking Systems. First, to obtain maximum stopping power using your ABS system, in the shortest distance possible as quickly as possible, apply both brakes to the point just before your ABS kicks in. To find this engagement point you will to have practice. Next, newer Harley's may have linked brakes. Where pressure on either brake will apply pressure on the opposite brake. The feature can be adjusted so that it does not engage below a predetermined speed. This makes sense to me, because at low speed you may want to apply the rear brake to help stabilize the motorcycles without using the front brake. See your Motorcycle Owners' Manual for specifics (MOM). Or talk to your dealer.

Now for this month's KK.

It is the time of year when animals are very active, as they are looking for or creating winter residence. It is my observation that there are more animals both small and large than ever before and they are not following previous year's protocol. I



saw a car hit the last of four deer at 3:30 in the afternoon on my pre-ride Saturday October

11th. It is very unusual to see so many deer out early in the afternoon, but the population has grown and they are on the move any time of the night or day.

Small animals, as cruel as it sounds, can be run over. Better to injure them than you or your mo-

torcycle. The general rule is if they are small enough for a one person meal then run over them. Better to kill one than be killed trying to avoid one. Of coarse you will probably need to clean the motorcycle later. Porcupines, skunks (pu), and large raccoons are probably better avoided.

Larger animals particularly those that herd should be avoided at all cost and you should slow to a walking speed when approaching them. Remember if you see one there are probably more of them.



Dogs can do geometry. When they see a motorcycle they calculate an angle of intercept. If you slow down they recalculate that angle. If and when you speed up they recalculate again but cannot run fast enough to catch you. So the best thing to do is slow down, let the dog take aim, then speed past the animal. Whatever you do, do not kick at the dog it can bite you or even get your pant leg and take you down.



As I sit here writing this article it is snowing, the leaves are almost all off of the trees, so be careful and cautious of frost, and/or wet leaves that is if you have not ended your riding season. Have a Happy Thanksgiving. Merry Holidays, and a wonderful 2015.

Tiered licensing: Utah has it, Illinois considers it, but will it affect sales?

Rumors that Illinois may institute tiered licensing for motorcycles are raising concerns about the impact it could have on sales in a still-fragile recovery. But would creating a new license class for more powerful engines really hurt?

Under current Illinois law, two-wheelers fall into two categories based on engine size, with the dividing line being

150cc. The state offers advanced rider training, but just 234 riders have taken advantage of it this year.

Secretary of State Jesse White raised the specter of adding a third category for vehicles with engines 600cc and above as a way to reduce traffic fatalities. The concern is that riders aren't training and testing for their skills on bigger, more powerful bikes. The interest is safety-driven but, dealers say, potentially misguided.

But it's difficult to tell, since the only state to tier licensing by bike size in the last decade, Utah, split licensing in 2008. That makes sales comparisons difficult at best, since the economy tanked immediately afterward.

Any proposal for Illinois wouldn't happen until next year at the earliest. Right now it's just in the idea

stage.

Dealers don't believe tiered licensing will do as much to improve safety as it will to harm sales. But that doesn't mean they oppose vigorous training.

"Any time we have restrictions or mandates imposed on our business, we are opposed to it," said Illinois Motorcycle Dealer Association president Jay Hall, owner of **Hall's Cycles** in Springfield. "Any time you make it more difficult to do something; people are less likely to do it. If it is harder to achieve what they want, it is not good for business."

"There's no tiered licensing on cars. A 16-year-old, if he has the money, can buy a Porsche with a lot of horsepower. I think we are being singled out," he said.



At **Woodstock Harley-Davidson**, co-owner and general manager Doug Jackson mostly agrees. He believes the law shouldn't require special training for higher-powered motorcycles but that riders should do it if they plan on operating bigger bikes.

"I think it's a travesty. I think there should be a better training program. The reality of it is, out of 50,000 people on our mailing list, not a lot of people are getting that training," Jackson said. "I am opposed to having the [tiered license] change because I think that wouldn't be good for dealers."

Jackson believes in thorough and appropriate training; he just thinks the state doesn't do it well. "The state has a lot to learn about putting together a riding test. I don't think that whoever put it together made it for these bigger bikes," he said.

More OEM support for larger-displacement training bikes would help, he said. Many OEMs don't provide enough 600cc and higher trainers, although Harley-Davidson has recently begun offering dealers a 500cc trainer.

"We have a riding school that is a little different than many riding schools. We train people on full-sized motorcycles. We can get them on bikes that fit them ergonomically, correctly," Jackson said. "If they are going to ride a Road King or a bagger, you end up training them on a Road King or a bagger."

The Utah experience

Under the Utah system, if a rider tests on a 90cc or smaller motorcycle or scooter, they are restricted to that size machine. The same applies with steps at 249cc and 649cc. Riders who test on a motorcycle larger than 650cc may ride any size motorcycle or scooter. Riders who pass a Motorcycle Safety Foundation Rider course are not required to take a riding test to get a motorcycle license.



"Many of the dealers have not seen much change because of the tiered license requirement. The bad economy changes that happened in 2009 and 2010 hurt the dealers, but they have since come back strong," said Daniel Terry, coordinator for the rider training program for Salt Lake Community College since 1994 and an MSF-certified rider coach since 2008. "I think it's foolish. I don't think cc's is a good measure, period. If you are going to do a tiered licensing, you need to make people test for the different tiers and base it off of skills, not cc's," he said. "You can put two 900cc bikes side

by side, and one is way too powerful and the other is a dog."

The law hasn't made anyone safer and may actually have had the opposite effect, Terry said. He advocates a system that gives all riders a limited license until they demonstrate advanced skills.



"The number of riders going through our training in 2008 was 1,400 students in my program alone," Terry said. "In 2009 it was cut in half. In 2010 it was down to 500. Even the economy did not account for the reduction. The number of people testing for motorcycle endorsements tripled.

"The skills test that most of the states are using is the one MSF put out a few years ago. It's a baseline. Anyone can pass the test if they have any physical abilities at all. Now we have people that haven't been taught the skills or any of the mental strategies that keep people safe on the highways."

Whether or not the law has improved safety, it may not have impacted sales, contended Gavin Hicken, general manager of **Plaza Cycle Motorsports** in Salt Lake City.

"I don't think it discouraged anyone [from buying] because a lot of the new buyers didn't know what the law was until they were looking for a motorcycle. It didn't bother them because they didn't know what the law was before," Hicken said. "The people that aren't going to get their motorcycle license and ride legally don't care what the law is."

Harley recalls: 105,000 Touring bikes, 1,400 Street models

Harley-Davidson is recalling more than 105,000 Touring motorcycles from the 2014 model year and 1,400 Street motorcycles from the 2015 model year for unrelated repair issues.

According to NHTSA, 105,746 Touring models from the 2014 year are being recalled because a component in the clutch master cylinder may fail, reducing the pressure available to keep the clutch disengaged. Vehicles affected by this recall include:



- Electra Glide Ultra Classic (FLHTCU)
- Ultra Limited (FLHTK)
- Police Electra Glide (FLHTP)
- Street Glide Special (FLHXS)
- Street Glide (FLHX)
- Tri Glide Ultra (FLHTCUTG)
- CVO Limited (FLHTKSE)
- CVO Road King (FLHRSE)
- CVO Breakout (FXSBSE)
- Electra Glide Ultra Classic Twin Cooled (FLHTCUTC)
- Ultra Limited Shrine (FLHTK SHRINE)
- Street Glide Shrine (FLHX SHRINE)
- CVO Softail Deluxe (FLSTNSE)

The Motor Co. estimates that about 10 percent of the recalled bikes have the defect.

Harley-Davidson told NHTSA it had received about 632 warranty claims and 266 customer contacts related to clutch functionality issues as of Aug. 19. "There were a total of 19 crashes (low speed tip over) with three minor injuries reported. There was also one report of an incident where there was non actual crash but a reported minor injury," the OEM stated.



Dealers will remedy the issue with a master cylinder rebuilt kit, which includes a plastic retaining ring that decreases the stress in the primary cup seal, the company stated.

Harley-Davidson separately is **recalling XG500 and XG750 Street motorcycles from the 2015 model year**, because the fuel tank filler neck may be "insufficiently flat," which prevents the fuel cap from sealing properly. Dealers are asked to inspect the motorcycle and test to determine whether fuel can leak from under the fuel cap. If a leak persists then the fuel tank has to be replaced, the Motor Co. indicated. About 1,400 vehicles are involved in this recall.

'Captain America' Chopper Sells for \$1.35 Million



A star-spangled chopper reportedly ridden by Peter Fonda in the classic film "Easy Rider" sold for \$1.35 million, making

it one of the most expensive motorcycles ever sold.

Profiles in History sold the bike for far above the reserve price of \$1 million. The chopper, known as "Captain America" for the name of Fonda's character in the 1969 film, was owned by collector Michael Eisenberg.

The price came despite media reports that cast doubt on the authenticity of the bike. An earlier "Captain America" chopper had been sold that also claimed to be the last remaining of its kind from the film.

Fonda said before the sale: "There's a big rat stinking someplace in this."

Perhaps we haven't heard the end of this story. But for now, some reports say the bike -- the real deal or not -- is the most expensive ever sold at auction.

AMA launches 'Vote Like a Motorcyclist' information campaign



The American Motorcyclist Association's 2014 "Vote Like a Motorcyclist" campaign provides members with exclusive access to an online voter guide, tips for getting a message across to candidates and resources for getting involved in a political campaign.

The '14 AMA Voter Guide includes candidate biographies, links to their campaign websites and candidates' stances on motorcycle-only checkpoints, public land grabs, increasing levels of ethanol in gasoline, health insurance discrimination and a variety of other motorcycle rights issues on Capitol Hill.

"If anti-motorcycling candidates win elected of-

fice, they can initiate legislation to take away opportunities to ride, cut back or eliminate funding for rider safety training, or wipe out programs that motorcyclists have spent years working to implement," said Wayne Allard, AMA's vice president for government relations.

"The AMA is a non-partisan organization and doesn't make political endorsements. But it does provide tools to help its members make informed choices on Election Day," said Allard.

A key component of the 2014 AMA Voter Guide is the candidate questionnaires and their "fuel-gauge" rating, indicating how supportive they are of motorcyclist-related issues. A full tank indicates a candidate is 100 percent in agreement with the priorities of the AMA and its members.

AMA members may post comments, videos or photos on each candidate profile page.

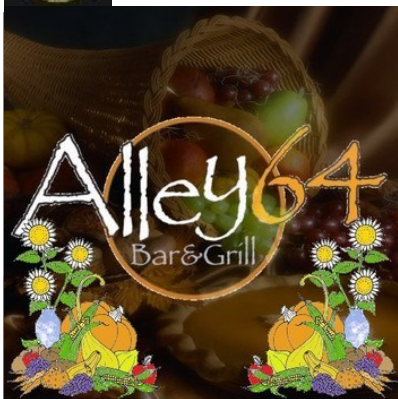


GENERAL MEMBERSHIP MEETING MINUTES

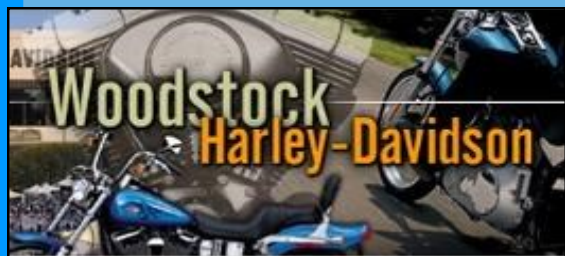

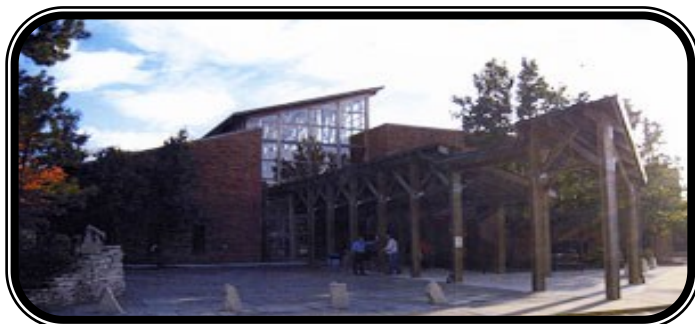
