KAUTION KORNER

Sharing the Ride...

Many riders will ride two – up at some time or another during their riding lifetime. Passengers, or co-riders, will fall in to two categories; trained and untrained. Trained

co-riders make riding two - up safer and enjoyable. Untrained co-riders can pose a hazard and....it's all up to the rider to 1.) determine their level of experience and 2.) train them to ride safely.

However, I would suggest that most riders have never been passengers or at best only have minimal miles of passenger experience so, their knowledge of what it is like to be a co-rider is very limited.

Let's change that and look at some of the dynamics of being a co-rider and how to ride with a co-rider....

When you carry a co-rider you have weight that can shift and affect the handling of the bike thru turns and curves, during stops and acceleration and mounting and dismounting the bike. If these weight shifts are sudden, unexpected, and drastic, they can contribute to an incident or accident. So, here are some tips for both the rider (**R**) and the co-rider (**CR**).....

Mounting / Dismounting

#1 R: Explain to the CR how you will be ready for them to mount / dismount i.e. when you have the bike stopped and balanced or kick stand down or engine shut off and when you say "OK".

CR: Always communicate your intentions to mount or dismount by asking if the rider is ready.

#2 R: Teach the CR what to step on, what to hold on to, and what not to touch (heat!) when getting on or off.

CR: Not sure? Ask.

#3 R: Leaning the bike on the kick stand provides a lower left side for easier access, assures that the bike is stopped and, gives you a more stable platform for the CR to get on / off.

CR: Let the rider know what is best for you, placing your leg over the rear seat and sliding on or stepping up on the floor board.



Accelerating/ Stopping

#1 R: Explain that the weight shifts to the rear when accelerating, making the front wheel light with less traction.

CR: Ride like you are best friends. It is OK and preferred to hold on to the rider. Makes for a more stable ride by keeping weight in the center of the bike. Leaning toward the rider during acceleration helps.

#2 R: Be prepared to brake harder with a passenger because you are carrying more weight and will take longer to stop. Look further ahead and slow down earlier.

CR: Don't slide forward into the rider under heavy braking. This pushes the rider forward and shifts weight forward making the rear wheel lighter with less traction. Keep from sliding forward by holding on to something on the bike, squeezing the rider with your knees and keeping your legs straight on the floor boards or pegs.

Turns / Curves

NOTE: A turn is a slow, 90 degree left or right like you'd find at an intersection. A curve is an open road bend to the left or right normally taken at posted speed limits.



#1 R: Teach your CR to read the road ahead and to mimic your movements.

CR: Anticipate what road conditions will cause the rider to swerve, stop, accelerate, or lean into a curve. Adjust your movements accordingly.

#2 R: Set up for curves by anticipating the additional weight of a CR. More weight = more momentum going into a curve thus more speed requiring earlier braking.

CR: Learn to lean no further than, but in the same direction as, the rider. Squeeze the rider with your knees to keep the center of gravity close to the center of the bike.

#3 R: Many turns are executed after a stop. Expect the CR to move and shift weight at a stop simply to remain comfortable. Start your turn after the CR is still.

CR: Remain as still as possible with no sudden moves at stops. It's OK to shift your weight a bit while stopped but remain upright and still during a turn.

Communicating

One of the most important aspects of riding with a Co - Rider is communications. Intercoms work

great but, if you have no intercom, establish some rules.

#1 R: Teach your CR to minimize chatter and to speak over the same shoulder each time.

Turning your head left and right to find out which ear your CR is talking into is a distraction.

CR: Learn to speak over the same shoulder to minimize distractions to the rider. Remember, everything you say to a rider may distract them from concentrating on the road ahead.

#2 R: Ask your CR for feedback and make corrections during each ride.

CR: Tell the rider when you are uncomfortable or hear a strange noise or need a rest stop. If you aren't comfortable, neither of you will have an enjoyable ride.

#3 R: Show the CR as much about the motorcycle as you can like, how the GPS works, what the gages should read, what a strange noise or vibration is. They can be a great help to you.

CR: By learning how to read the GPS, you'll know when the rest stops are, how long to the destination, if or when the rider will be slowing to turn. Learning about the gages will also let you know things like oil pressure and voltage which is critical to safe operation. If something looks wrong, tell the ride immediately.

Riding together improves with experience and communications. Remember.....

- ▶ No sudden moves,
- ▶ Minimal and succinct communications
- ▶ Mutual concern for safety and comfort
- ▶ Identical safety equipment.....

.....will make any ride, for any distance, under any conditions, safe, enjoyable, and memorable.

the column reach all of you and after you think about it.. That it will be the starter of good conversations and new ideas.

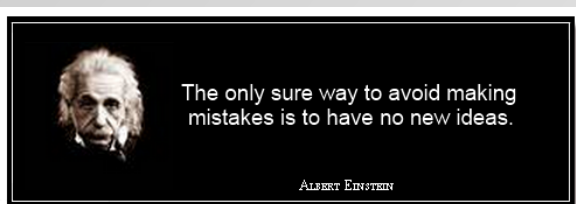
So, now it's your (the members) turn. Give me your ideas for any of our existing committees or ideas for new ones. Maybe some new activities... anything that might be

Motorcycle thefts down 6 percent in 2014

Motorcycle thefts in the United States were down 6 percent in 2014, according to a report the National Insurance Crime Bureau (NICB)



released today.

A total of 42,856 motorcycles were reported stolen in 2014 compared with 45,367 reported stolen in 2013—a decrease of 6 percent. The drop comes as overall motorcycle sales in 2014 increased by 4 percent over their 2013 total, according to Motorcycle Industry Council figures.

The top 10 states with the most reported motorcycle thefts in 2014 were California (6,355), Florida (3,981), Texas (3,274), South Carolina (2,146), North Carolina (2,117), New York (1,544), Indiana (1,508), Nevada (1,488), Georgia (1,455) and Maryland (1,127).

The top 10 cities for motorcycle thefts in 2014 were Las Vegas (1,163), New York (1,034), San Diego (650), Miami (541), San Francisco (516), San Antonio (447), Houston (439), Indianapolis (422), Los Angeles (397) and Albuquerque, N.M. (390).

The top 10 most stolen motorcycles in 2014 by manufacturer were American Honda Motor Co., Inc. (8,045), Yamaha Motor Corp. (6,728), American Suzuki Motor Corp. (5,987), Kawasaki Motors Corp., U.S.A. (4,497), Harley Davidson, Inc. (4,146), Taotao Group Co. Ltd (1,730), Astronautical Bashan (535), Jonway Group Co., Ltd. (503), KTM Sportmotorcycle AG (489) and Genuine Cycle (449).

The most motorcycle thefts occurred in August (4,965) and the fewest in February (1,978) reflecting a weather-influenced pattern that is consistent with previous years.

Harley-Davidson to cut 250 salaried jobs

Harley-Davidson will cut about 250 salaried jobs as part of a reorganization to focus on increased marketing announced in the [Motor Co.'s third quarter financial report](#).

The company said Oct. 20 it expects to incur one-time expenses of about \$30 million to \$35 million in the fourth quarter, primarily for employee separation and reorganization costs.



Spokesman Tony Macrito elaborated to the [York Daily Record](#), saying the cuts would not affect hourly employees.

"An early retirement incentive program will be offered to eligible employees in advance of what we believe will be a global reduction of around 250 salaried positions across the company, largely completed by the end of the year," Macrito said. "Adjustments in positions and structure will be made in essentially every part of the business to achieve the right focus and support the increased demand-generating investments."

Final Love Ride raises \$1 million for Wounded Warrior Project

The final Love Ride held last weekend raised more than \$1 million for the Wounded Warrior Project,

organizers say.

Grand Marshal Jay Leno, Foo Fighters, Social Distortion and a star-studded cast of riders including the Harley-Davidson Royal Family - Willie G, Nancy, Bill and Karen Davidson - actors Peter Fonda, Robert Patrick, Emilio Rivera, Lorenzo Lamas, Kristy Swanson, Sean McNabb, Phillip Winchester, Mark Boone Junior, George Gray and countless others joined forces last weekend to support the Love Ride Grand Finale concert and festival - the largest and longest-running one-day motorcycle charitable fundraising event in the world, put on by an army of 750 volunteers.

Riders and attendees who participated won prizes such as a 2015 Harley-Davidson Black Street Glide motorcycle, an all-expense paid trip to the Harley-Davidson Factory and Museum in Milwaukee, a tour of Jay Leno's Garage and more. Full winners listed on the Love Ride website at www.loveride.org

After 32 years of service, this was the Love Ride's curtain call. In the words of the festival's founder, Oliver Shokouh; "It's been my honor to serve these causes for decades. I'm eternally grateful for the outpouring of support that so many gave this year as we ride off into the sunset with over \$1 million raised for Wounded

Warrior Project and a total legacy of over \$25 million for charities to date. Lives are changed because of your tendance and

participation over these years and I thank you from the bottom of my heart."

When we interact with someone “in the business,” usually we have a singular view of that person. His other interests and priorities are not visible to us. We’re not aware of how much this person loves his wife and children, how devoted he is to his

Chris was an admired and respected GM. I first met him after McHenry Harley-Davidson had won its first of multiple Top 100 awards, and then got to know him a little better when we were working on the dealership’s [cover story back in November 2013](#).

McHenry H-D was a reflection of Chris’s personality—friendly and relaxed, but with an uncanny attention to customer. I had visited quite a few dealerships where I could walk around for a half hour without not so much as eye contact with a staff member. But at McHenry H-D, I walked in and was greeted in 18 seconds. I told Chris how much I appreciated that. He raised his chin slightly, looked out at the showroom with a soft smile, and whispered, “OK, well, we’re having an event. It should have been 10 seconds.”

Ride in peace, Chris.
You were one of the good ones.

Honda recalls 145,000 motorcycles



American Honda Motor Co., Inc. (Honda) has issued a recall affecting 145,219 bikes after it was determined that a rear brake that drags may increase the risk of a vehicle crash. Also, extended

riding with the rear brake dragging could generate enough heat to result in a fire.

This recall involves certain model year 2001-2010 and 2012-2015 GL1800, 2001-2005 GL1800A and 2013-2015 GL1800B motorcycles. The rear brakes of the affected motorcycles may drag after the brakes are released.

Honda will notify owners, and dealers will replace the secondary brake master cylinder and the rear brake master cylinder, and flush the brake fluid, free of charge. The manufacturer has not yet provided a notification schedule. Owners may contact Honda customer service at 1-866-784-1870. Honda's number for this recall is JV6. Note: This recall supersedes recall 14V-472.

Richer had been SVP of Marketing since 2007 and eventually had marketing, global demand (sales) and new customer outreach among his direct reports as CMO. Sean Cummings, who joined HOG in 2014 and recently led Latin America sales, will become SVP of Global Demand. Shelly Paxton will become VP of Marketing and Brand.”

Stay Safe Out There!

By now most of you likely have seen on social media or in news reports the road rage incident in Texas where a driver, apparently intentionally, swerves into a motorcycle passing him on a double yellow centerline. The passenger on the motorcycle received serious injuries and the driver of the car, on a video filmed by another rider, when asked why he did it, said, “I don’t care.” Fortunately, this incident didn’t result in a rider fatality, but plenty of other road rage incidents, usually involving cars, have, including a recent one where a four-year-old child was shot and killed.

There is something in the psyche of some car drivers, which demonstrates the disregard for people operating vehicles smaller than theirs and can trigger a road rage.

At the risk of pointing out the painfully obvious, motorcyclists, even those wearing full protective gear, are no match for a 4,000-pound or heavier vehicle. As riders, we have to choke-



down our emotions and not do something, like delivering a certain hand gesture or yelling profanity, which may trigger road rage behavior.

It is appropriate, if the opportunity safely presents itself, to respectfully let an offending driver know when their actions have put the rider in danger. Most drivers will respond positively to this and perhaps be more vigilant in the future. Absent that opportunity and driver response, though, it’s best to just let it go and live to ride another day.

In the Texas incident, however, it was the overt act of the motorcyclist passing the driver on a double yellow centerline, which, apparently, triggered the road rage. At some time or another, probably most, if not all, of us have been stuck behind a slow vehicle and been tempted to pass, or have passed, on the double yellow. The superior power-to-weight ratio of a motorcycle, compared to other vehicles, often means that there may be more room for the motorcyclist to safely pass others than the yellow no passing lines are calibrated for.

Other forms of perceived, or real, aggressive riding by motorcyclists also may trigger an unexpected, life-threatening road rage response from a seemingly normal and sane driver. Even if these “ticking-time bomb” drivers are a small percentage of the total driving public, they are virtually impossible to identify in advance from the seat of a motorcycle. Riders must be fully aware of the additional risk they are assuming when engaging in behaviors that might trigger a road rage response. This is just something to keep in mind as you share the road with much larger vehicles.

Indian recalls 7,611 motorcycles with rear brake assembly problem

Indian Motorcycle Co. is recalling certain 7,611 motorcycles from the 2015 and 2016 model years to replace the rear brake master cylinder piston assembly.



Affected are 2015-16 Chief Classic, Chief

Vintage, Chieftain and Roadmaster motorcycles, and 2016 Dark Horse models, all manufactured from Jan. 2 to Oct. 23. Due to the problem with the existing rear brake master cylinder, the motorcycles may experience a reduction in, or complete loss of, rear brake power, NHTSA announced.

"We recently discovered that our supplier provided a portion of the rear brake master cylinder that does not meet Indian Motorcycle quality standards," the OEM told owners. "Indian Motorcycle dealers will replace the rear brake master cylinder piston on all motorcycles that could potentially be affected by this issue." The recall (NHTSA Campaign No. 15V721000) is expected to begin Nov. 13. Indian said service parts will be available for dealers to order immediately.

Woodstock H-D to raffle IMS custom trike in Veterans Day benefit

After two years touring the country in a fundraising campaign at Veteran events, rallies, conventions and trade shows, an International Motorcycle Show stage-built custom trike will get a forever home on Veterans Day. The H.E.R. (honor, encourage and recognize) Project trike will be raffled off at **Woodstock Harley-Davidson**. In partnership with the dealership, which donated the trike, the [XX Chromes All Women Bike Builders](#) built the trike on stage at the IMS in 2013. It traveled around the United States in and has been to Washington, D.C., with the Rolling Thunder motorcycle organization and a million other motorcyclists.



"We have raised \$22,000 for Disabled American Veterans with the help of Woodstock Harley-Davidson. Owners Doug and Cricket Jackson and their entire

team are huge supporters of Veterans and their families," said Gina Woods, creator of the H.E.R. Project. "It's been an amazing journey meeting and talking with the men and women of our great country that have served or have had someone in their family serve. We have had an outpouring of support on this project since the beginning with Tammy Duckworth's endorsement and signatures from celebrities such as Gary Sinise, former Chicago Bear John Janata and Green Bay Packer Lee Roy Butler."

House Adopts Highway Bill Amendments Beneficial to Motorcyclists

The U.S. House of Representatives adopted amendments to the federal Highway Bill last week that includes good news for on- and off-highway motorcyclists, the American Motorcyclist Association announced.

The Surface Transportation Reauthorization and Reform Act of 2015 approved last week by a vote of 363 to 64 provides \$325 billion over six years.

Amendments and other provisions passed by the House and supported by the AMA include:

- Continued funding for the Recreational Trails Program which provides funding to states for maintaining, improving and expanding off-highway recreational opportunities;
- A prohibition against using federal funds for motorcycle-only checkpoints;
- Reestablishing a Motorcycle Advisory Council to coordinate with and counsel the U.S. Department of Transportation administrator on infrastructure concerns of particular interest to motorcyclists.

Authorization for a study to be performed by the National Academies of Science on ways to prevent crashes; and

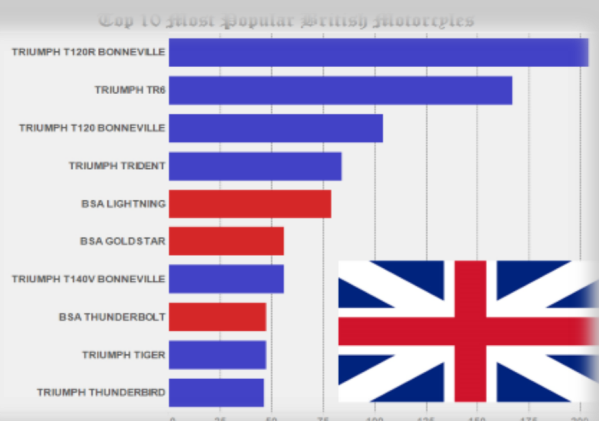
- Funding of highway safety grants that include programs to reduce distracted driving, including language that make it easier for states to successfully qualify for and receive the money.

The AMA supported a provision that would have banned the U.S. DOT from lobbying local, state or federal governments about policy issues. The House Rules Committee removed that amendment from consideration. However, the AMA hopes to get the language restored as the bill moves forward.

The Highway Bill now goes to conference committee, where differences between the Senate and House versions will be worked out.

GRAPH OF THE WEEK: THE 10 MOST POPULAR CLASSIC BRITISH MOTORCYCLES

Classic British motorcycles and their enduring popularity have a similar story to British sports cars. The United Kingdom lived by the “Export or Die” mantra during the immediate postwar years, and Britain’s industries ramped up production for sale abroad, particularly across the pond in the U.S. Motorcycles actually made up one of Britain’s largest industries behind automobiles for much of the post-war period, and almost everyone who was buying a large bike that wasn’t a Harley was buying something made in the British Isles. The period from the end of World War II until the Japanese invasion of the 1970s was a golden age for British bikes.

American riders bought Vincents, Nortons, Velocettes, Ariels, Royal Enfields and more, but as far as sales and popularity go, there are two marques that

stood above the rest: BSA and Triumph. This is shown in their popularity as classic motorcycles today.

After acquiring Triumph Motorcycles in 1951, the BSA Group quickly became the largest motorcycle manufacturer in the world and the majority of both Triumph and BSA production for much of the 1950s and 1960s was exported. During the 1960s, Triumph had about half of the U.S. market for large bikes.

For both Triumph and BSA, the massive number of examples built (over 28,000 [Bonnevilles](#) in 1967 alone), ample parts availability, and rich history that includes racing success and appearances in pop culture make them practical, appealing classic bikes and explains why they’re the two most ridden classic British makes today.

Harley-Davidson extends free military rider training

Harley-Davidson will extend its offer of free Riding Academy motorcycle training to all current and former United States military for another year, making the training available through Dec. 31, 2016.



To continue its salute to the military, Harley-Davidson managing director and former U.S. Army officer Christian Walters will escort fellow veterans, including Dorsey Fyffe, a former U.S. Air Force flight engineer and Wounded Warrior Project peer mentor, to America's Parade in New York City aboard a Bell 407 U.S. Army helicopter Nov. 11.

The original offer of free Harley-Davidson Riding Academy kicked-off prior to Armed Forces Day aboard the USS Yorktown aircraft carrier in Charleston, S.C., making it only fitting to take to the air to announce the free training extension.

If Riding Academy is not available in a particular area, Harley-Davidson will reimburse the expense of attending a certified motorcycle safety program. Those currently deployed outside the U.S. also can submit the form by Dec. 31, 2016, and will receive a voucher for free motorcycle safety training good through 2017 when they return home.

Annually we have the opportunity to either vote to confirm a slate or to choose candidates for our Board of Directors and our Executive Committee for the coming year. Annually, we verify our members who are eligible to vote and who are eligible to run for office based on Club participation, dues, GRASS attendance, committee service, etc, consistent with our Bylaws.

As we approach this key, and critical, Club event all of us should be reminded of the impact of our vote....

Ideally, with our vote we are continuing the great legacy of Top Cats – Illinois into our 21st year and selecting the best possible candidates to run our Club consistent with our By Laws. Ideally, each of us will cast our vote to select or confirm candidates based on their proven performance, dedication, and contributions to the Club. Ideally, our selections will not be based on personal friendships alone, animosity, or in retaliation toward the Club, its leadership, or its members.

When you find yourself faced with a selection decision, simply look at your choices and determine 1.) Who has the best interest of the Club at heart, 2.) Who has a proven record of dedication to the Club, 3.) Who has the experience for that particular position and, 4.) If all else is a tie, ask yourself who you see at every ride, every meeting, every committee activity, every Club event, and every charity ride. That should help you decide.

NOMINATIONS. We have a wealth of eligible candidates this year and we are very fortunate to have each incumbent accept a nomination for another term. The positions up for election / reelection this year are:

Eligibility for nomination includes; dues paid, attend a combination of 5 meetings/events per year, GRASS attended within the last 3 years, service on the Board or on a committee. In addition to the incumbents, members eligible for nomination to run for President, Vice President, or director, subject to their acceptance will be published after the 30 Oct due date for dues. At that time we ask that nominations be received by a serving Board member by 15 November 2015.

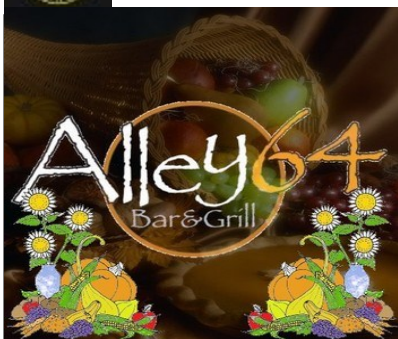

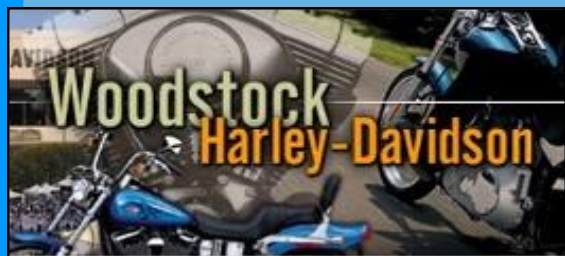
