

There are many types of road hazards we encounter your gauges as well. This includes parent reason, soon-to-be road kill and gravel roads. I and react as safely as possible. leave those road issues to your judgments. I will explain here a simple principal I follow to deal with the most common road hazards I encounter on my motorcycle. If you follow this common motorcycling principal, you will better handle what the road dishes out to you on your many bike rides and trips.

It is a simple strategy that is fairly easy to understand and employ. The main element is scanning. quicker you can identify a problem, the easier it is to avoid.

#### Scanning

This process doesn't just involve looking ahead. You should be sweeping your field of view from left to right, near and far and from time to time including

#### Predict

This one is a little tricky. You sometimes need to predict the rates of speed you're traveling and other moving objects about to cross your path, is the road ahead Sometimes, though things may get past you. 
#### **Decide**

This is just like it sounds. After predicting a future outcome, you *decide* what you are going to do to deal with the road hazard you identified is coming upon you while scanning ahead. This is where motorcycle training can play a big part. If you attend Top Cat's G.R.A.S.S. classes and learn from other sources about driving your motorcycle safely, you will act more automatically. Training helps reinforce safe riding ideas and ingrain them in your head so when you encounter an unsafe situation you are better prepared to react in a natural manner, almost like second nature. Training is an important element in making faster decisions. The act of decision also includes making a plan. Sometimes at 50-60 miles per hour. Piece of cake!

#### **Execute**

Finally, now we get to doing something on the bike! Action! This is where the rubber stays on the road (hopefully) and you successfully manage your road hazards. This can mean doing almost anything on the bike but not in a reactionary way if you follow SIPDE. This can include many things; swerving, staying the course, slowing down, speeding up, stopping, etc. Whatever you decided you need to do you act upon.

The last thing to consider is that you perform the SIPDE principals constantly. You continually are scanning, identifying, predicting, deciding and executing while you are doing the same. This ultimately means that what you scanned, identified and decided is a changing environment and thus, you decisions on a course of action or execution of your decisions are constantly changing. This is a continual cycle (pun intended) that you ride over and over while you navigate your motorcycle down the road of life. If you follow SIPDE you will be safer for it.

#### America Wins International Six Days Enduro **First Time**

The U.S. World Trophy Team dominated the 2016 International Six Days Enduro, the longest -running team world champion-



ship in motorcycling, winning the ISDE World Trophy for the first time. Held in Navarra, Spain, on Oct. 11-16, it was the 91st running of the ISDE since the Fédération Internationale de Motocyclisme event was founded in 1913.

The U.S. World Trophy Team defeated runner-up Great Britain by 3 minutes, 38.66 seconds, a lead accumulated over six days of racing. The U.S. team was led by Taylor Robert, who was the top individual rider at the event. Robert's teammates were Kailub Russell, Thad DuVall and Layne Michael.

The Trail Jesters, made up of Josh Toth, Ben Kelley and Jason Klammer, finished second, and the Eric Cleveland Memorial Team, made up of Jimmy Jarrett, Broc Hepler and Alex Dorsey, finished third in the team standings.

> Toth, who competed in C1, was the top individual rider among the 381 entrants in that division, winning by more than 2 mintues. Kelley won the C2 class, and Hepler finished third in the C3 class.

> This year's ISDE was the first year for the FIM Enduro Vintage Trophy. American Fred Hoess, competing on a 1986 WR250 Husqvarna, won the overall.

> "I rode here in Spain in 1985 on basically the same bike as I rode this year, and I'd have to say on Day 5, when we were riding in the mountains and I'd look up at the scenery and smell the two-stroke oil and the burning clutch plates, I'd swear just for a second I was back in Spain and it was 1985 again," said Hoess, who had competed in 25 ISDEs prior to this year's special vintage competition.

Indian Motorcycle has announce that the #001 2016 Limited Edition Jack Daniel's Indian Chief Vintage motorcycle auctioned at Barrett-Jackson Las Vegas on Saturday October 15 raised \$150,000 for the benefit of Operation Ride Home, a program that assists active duty U.S. military personnel in traveling home to visit their families through a meant to be enjoyed separately. Finally, both models also partnership with the Armed Services YMCA.

One hundred fifty individually numbered 2016 Limited Edition Jack Daniel's Indian Chief Vintage and Indian Springfield motorcycle models were made available for purchase on March 4, 2016, for \$29,999. All but #001 of the 150-unit production run sold in just eight hours on the first day of availability, with that first unit being saved for this auction. These motorcycles represent the first time in the century and a half history of Jack Daniel's that any vehicle has had an officially sanctioned Jack Daniel's livery,

making this motorcycle even more special.

# A New Top Cat You Should Know... Bob Morrison

Bob Morrison and his wife Nancy have lived on two wheels for a very long time. Bob-grew up in Niles, born in Chicago, and Nancy was born in Chicago, grew up in Milwaukee and moved back to Chicago during High School – just so their paths would cross - and their story is filled with many motorcycling experiences!

Bob attended Nile West HS, Washburne Trade School, Oakton Community College, and Harper College. Nancy graduated from Taft High School and attended Wright Junior College. Bob began riding with mini bikes and a Lambretta motorscooter in the late 60's, and this evolved into riding motorcycles in 1973.



Since then he has had a variety of bikes including a 1973 Yamaha RD350, a Kawasaki KZ900 and a Harley Davidson Heritage Deluxe Classic.

In his youth, Bob was well on his way to being a Renaissance man. He was in the Cavaliers' Drum and Bugle Corp, racing at Union Grove with a Cuda and Firebird, and a bit of camping and fishing complete the picture. The camping and fishing started at a very early age and ended up being a great way to connect with Nancy, who also loved camping and has always had a great interest in animals. In her youth, Nancy worked as a vet tech for many years and today both Bob and Nancy support The Valley of the Kings in Sharon, Wisconsin. It is a sanctuary for large cats who need a safe place to live out their years. Bob and Nancy will transport any kinds of food to the sanctuary and spend many Sundays there caring for the animals and their habitat. They also support the Feral Feline Project, the Buddy Foundation and other rescues.

Their story began when the two met on May 26th 1978. Bob was out with friends riding, and met Nancy. He asked if she would like to go out to dinner sometime. She took his phone number and a few days later she called and they went out for dinner. Bob then asked her if she would be interested in going to a motorcycle rally in the days following that first date. And they did go to that rally. It was at Beech Bend Park in Bowling Green Kentucky. They actually closed the deal on their present bike while at Beech Bend. To make a long story short, The "Big Boogie", as it was called, was like a bikers Woodstock, Nancy had never been to a rally before..... Ask Bob about how the rest of that went! It was a long time before they went to any other rallies.

After marrying, on October 18, 1980, they began working and building their future together. Nancy worked for Walgreen's for 34 years. She started in 1978, and spent years as an SOS Clerk. She managed an over the counter drug department and managed the inventory. Her last position was to manage the Home Health Care Department with medical equipment. Bob was a plasterer, starting in 1978 with Plasterers Local 5. Through the years, he spent twenty-five years as a Foreman and then a Superintendent for over 5 years. He also became involved with the Union and was on the Board of Arbitration and the Executive Board. He serves as the Vice President for 2 terms and the President for 2 terms.

The two loved riding, through these years, and rode solo on many cross country trips until the late 90s, always 2-up. The two spent these trips camping and experiencing the best of fresh air and panoramic scenery. There were some years without riding, but after both taking an early retirement, they were able to move back onto the open roads.


When they have some extra time, Bob can be found fishing, which he has loved since a very early age. He would go with his Dad and brother, Tim, on the weekends from spring until fall. There is a greenhouse in the Morrison's yard, where Bob can be found daily. It's an intermediate house about 11 x 16 where he grow orchids, and other tropicals. To cover both of their interests, it's also used for a cat colony who have access to the greenhouse all year round. In their 'free' time... well, they don't have any children, but they still have Bob's mom and dad along with Nancy's three sisters and Bob's brother.





**NOMINATIONS.** We have a wealth of eligible candidates this year and we are very fortunate to have each incumbent accept a nomination for another term. The positions up for election / reelection this year are:
