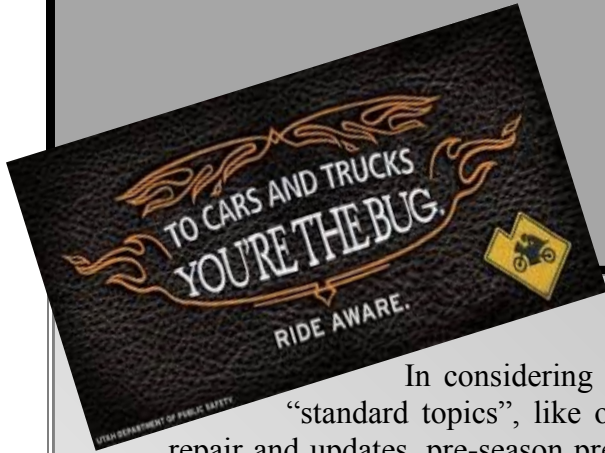

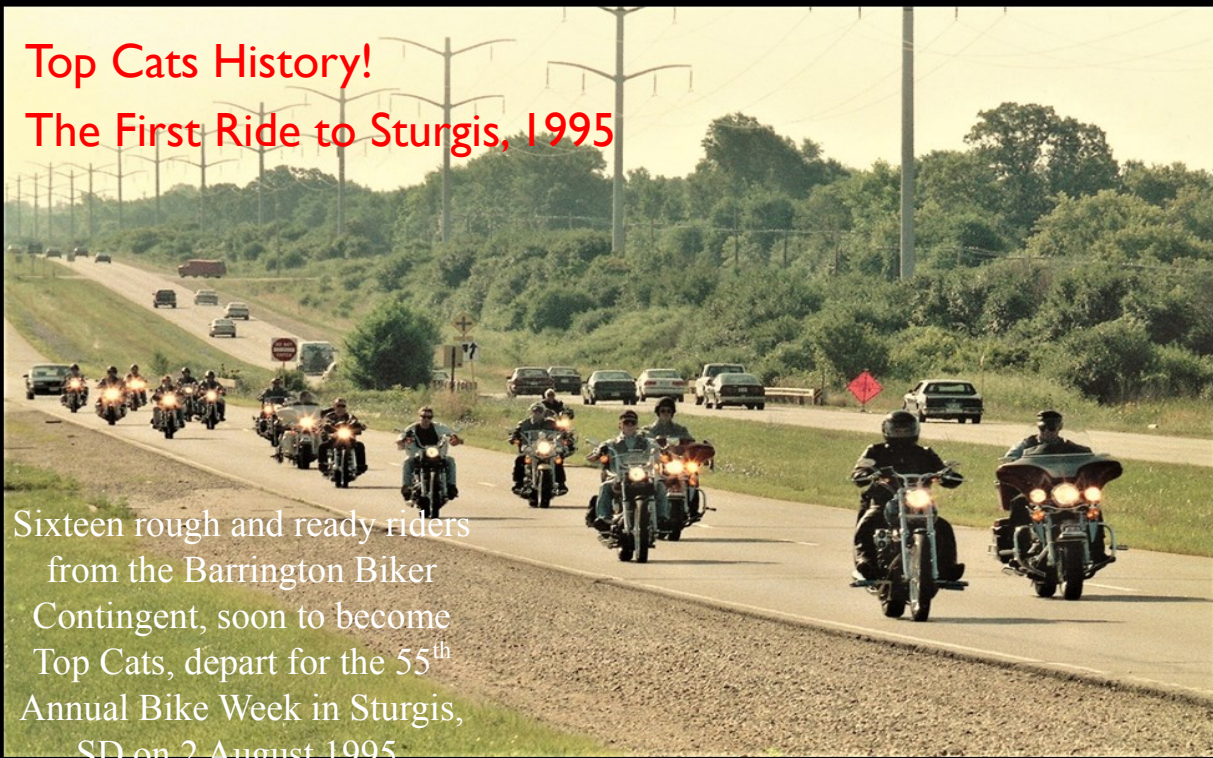

Top Cats History! The First Ride to Sturgis, 1995



Sixteen rough and ready riders from the Barrington Biker Contingent, soon to become Top Cats, depart for the 55th Annual Bike Week in Sturgis, SD on 2 August 1995.

Barrington Biker Contingency had 16 members when they got started. They loved to ride, and were loosely organized around motorcycles. This group began the trip to Sturgis with tight formation, as is seen above. Emil Kornecki, Bard Boand and Jim Heniff were part of the ride. Their destination was decided without the use of 'google' or other information websites. So, plans were made and Emil led them to the Dakota Rose and they arrived after dark.

In the morning, one of the guys, Phil Blasé, went out for his first cigar of the day -one of his daily 10-12, as the story goes. Being a friendly guy, he tried to start a conversation with another biker who had come in during the night. The Bandito did not feel as friendly as Phil, so the conversation screeched to a halt. Ice filled the otherwise very warm air.

Later in the day, when there was a Bandito bike that had trouble starting, the TC club members had the needed tool and went over to help. Thus, starting the Safety and Service Heart that has become a cornerstone of the Top Cat's Reputation. The rest of the Banditos were impressed and the ice was melted...

Another little known fact came from the first edition of the club publication... The reason the club does not meet on Sundays and has always met on Tuesday was identified. The original newsletter discussed the issue:

Well, the intelligent people at the meeting made some interesting observations for example: SUNDAYS are precious and no one wants to sit inside at a meeting on a gorgeous day like Sunday was; Some retailers must work on the weekends and just cant get away; Sundays are family days for a lot of folks...So... We decided to change the day to Tuesday.

Polaris winds down Victory brand

Polaris Industries Inc. announced it will immediately begin winding down its Victory Motorcycles brand and related operations. Polaris will assist dealers in liquidating existing inventories while continuing to supply parts for a period of 10 years, along with providing service and warranty coverage to Victory dealers and owners.



"This was an incredibly difficult decision for me, my team and the Polaris Board of Directors," said Polaris Industries Chairman and CEO Scott Wine. Since inception, our teams have designed and produced nearly 60 Victory models that have been honored with 25 of the industry's top awards. The experience, knowledge, infrastructure and capability we've built in those 18 years gave us the confidence to acquire and develop the Indian Motorcycle brand, so I would like to express my gratitude to everyone associated with Victory Motorcycles and celebrate your many contributions."

The competitive pressures of a challenging motorcycle market have increased the headwinds for the brand. Given the significant additional investments required for Victory to launch new global platforms that meet changing consumer preferences, and considering the strong performance and growth potential of Indian Motorcycle, the decision to more narrowly focus Polaris' energy and investments became quite clear.

"Our focus is on profitable growth, and in an environment of finite resources, this move allows us to optimize and align our resources behind both our premium, high performing Indian Motorcycle brand and our innovative Slingshot brand, enhancing our focus on accelerating the success of those brands, said Scott Wine.

Polaris remains committed to maintaining its presence in the Spirit Lake, Iowa community with Indian Motorcycle production and in the Huntsville, Alabama community with its Slingshot production.

AMA objects to higher tariff on European motorcycles

The American Motorcyclist Association strongly objects to a federal agency's attempt to tack a 100 percent or higher tariff on motorcycles made in Europe as part of a trade battle over hormones in U.S. beef.



COW-A-SOCKY

The Office of United States Trade Representative proposes to include tariffs on motorcycles with an engine size between 51cc and 500cc imported from the European Union.

The American Motorcyclist Association opposes the proposed tariff, because trade disputes residing within the boundaries of the agricultural industry should not be solved with trade sanctions levied against non-agricultural products.

"There is no logical link between motorcycles and beef," said Wayne Allard, AMA vice president of government relations. "It is absurd to even consider such a move.

Affected manufacturers include Aprilla, Beta, BMW, Ducati, Fantic, Gas Gas, Husqvarna, KTM, Montesa,

Piaggio, Scorpa, Sherco, TM and Vespa.

The same agency tried the same tactic in 2008, but the effort was thwarted when the AMA, the Motorcycle Industry Council and bike manufacturers and retailers rallied motorcyclists against the plan. At that time, the U.S. Trade Representative instead raised the tariff on a variety of European food products.



Three Harley-Davidson dealerships sold to dealer group

Three Harley-Davidson dealerships — located in Woodstock and McHenry in Illinois and Lake Geneva, Wisconsin — have been acquired by the Windy City Motorcycle Company. The dealerships are McHenry Harley-Davidson, Woodstock Harley-Davidson and Lake Geneva Harley-Davidson.



The addition of these stores brings Windy City Motorcycle Company's network to 13 dealerships in Illinois and Wisconsin, including ten dealerships and three retail centers. With the purchase, Windy City Motorcycle Group becomes the country's largest Harley-Davidson dealership group.

Ozzie Giglio, principal of Windy City Motorcycle Company, said in a press release.

When The Windy City Motorcycle Company began in 2001, they had just one location and only 14 employees. In the last 16 years, WCMC has grown in both size and spirit, now employing over 400.

WCMC has helped to connect riders from all over the globe. Their renowned motorcycle tours offer guided trips to Sturgis and along Route 66, with riders coming from Europe and Asia to participate. They offer more guided rides than any other motorcycle company in the country, and they also offer free rider education (more than 1,000 students learn to ride each year thanks to WCMC), as well as free winter storage. (Over 3,000 bikes “winter” in the Chicagoland dealerships).

The Windy City Motorcycle Company offers a personalized rider experience that ensures each client’s needs are met, whether they are seeking a new bike, a repair, merchandise, or simply to become part of a riding community.

“Thanks to our many locations, we are best positioned in the industry to not only offer competitive prices and a highly-trained staff, but also to offer an enhanced rider experience,” Giglio said. “Our size and scope mean that riders never have to worry about breakdowns or finding engine parts when they are on the road. Whether you need to buy a part in McHenry and return it in Milwaukee or you want to rent a bike in Palatine and return it to Woodstock, our large family of dealerships makes that possible.”

“As in the past, these most recent acquisitions by WCMC were thoughtfully executed with the past owners’ guidance, and we will retain the existing staff and management,”

EBR Motorcycles is finished... again!



It’s beginning to become a regular occurrence, but EBR Motorcycles looks to be finished, again. A statement released by EBR – the firm that rose out of the ashes of Buell – has confirmed that the company will be winding down its production operations as of next week, with a sale of production equipment and excess parts happening from March. It looks like this time company will be finished for good, though we have said this before.

After filing for bankruptcy as recently as April 2015, the Wisconsin company managed to find a last-minute investment from Hero MotoCorp Ltd, which owned 49% of the company and American Metals LLC with the aim to get the EBR Motorcycles back up and running as a fully formed manufacturer.

The decision to “wind down” comes just a couple of months after the announcement of the Black Lightning, a street focused version of the company’s 1190SX model. “The decision was a tough one for EBR as it has been solely focused on the growth and building EBR for success.” With a failure to meet sales and production targets “this difficult decision was based primarily on EBR facing significant headwinds with signing new dealers, which is key to sales and growth for a new company. The combination of slow sales and industry announcements of other major OEM brands closing or cutting production only magnified the challenges faced by EBR.”

EBR Motorcycles was formed off the back of Buell motorcycles as an independently-owned outfit in 2009 after Harley-Davidson, who wholly owned Buell, offloaded the marque to focus on its own core brand.

EBR will continue to honor warranties on their motorcycles and have pledged that they will also provide support and parts to dealers and riders, though they haven't confirmed a longstanding solution to parts availability further down the line.

Hotel offers custom motorcycle service



A hotel in Charleston, South Carolina, is offering guests the chance to build their dream custom bike.

The Restoration Hotel underwent a \$27 million transformation in the recent past and the Open Road custom motorcycle program was created in tandem with local bike builder Ivan Remus as part of the relaunch.

Remus charges hotel goers a \$500 consultation fee, which he adds to the overall price of the finished bike if they go ahead with the project.

Once the base bike and parts are secured the job of customization takes four to nine months to complete. Prices vary between machines, dependent on their parts and labor

In the hotel's front entrance lies a modified 1976 Honda CJ360. It sits below a large picture of the bike being ridden through the dirt by Mr Remus.



The bike belonged to Ivan until the hotel's Creative Director Cory Ingram contacted him and asked if he would sell him the bike and come on board as the design consultant and builder for the Open Road program.

Open Road is just one of many services offered by the hotel and all were devised by Mr Ingram in order to celebrate local artists and create a greater sense of community within the area.

All of these things are great but they are not the most important

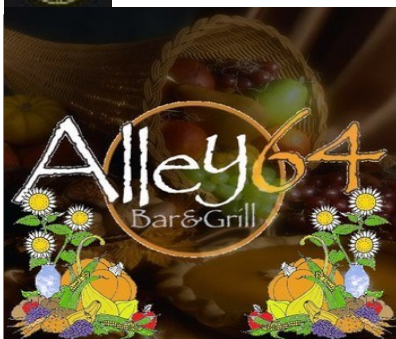
