### Riding Safely Around Trucks and Busses By: Mike 'Motorcycle' Bradbury, Senior Road Captain and Club President



We encounter a plethora of challenges while riding our motorcycles. Many of these road challenges seem daunting but usually, when learning simple guidelines, are so much easier to safely manage. I intend to offer guidelines here to safely ride your motorcycle, alone or with others around trucks and buses.

Large trucks and buses (commercial motor vehicles or CMVs) have operating limitations such as large blind spots, long stopping distances, and limited maneuverability that make it essential for other vehicles to put extra focus on safety, including and especially on our motorcycles

Fortunately, motorcycle drivers can take simple actions to avoid experiencing or causing problems involving trucks and buses by following these simple safety guidelines to safely manage driving around these types of vehicles.

### 1. Blind Spots

Large trucks and buses have huge blind spots around the front, back, and sides of the vehicle. If you can't see the driver in the truck's side mirror, assume that the driver can't see you. Don't drive in a blind spot – slow down or move ahead to stay visible. Be particularly careful when merging near a truck or bus. You may likely be in a blind spot.



### 2. Passing Safely

Position yourself in the left track by the center yellow line. When leading a group, signal them into single file. Look ahead and estimate enough time to pass unobstructed by oncoming traffic. Include extra sufficient time for others when leading a group. Make sure you can see the driver in the side view mirror before passing. Signal clearly then move into the left lane and immediately accelerate so that you can get past the truck or bus safely and promptly. Don't linger in the blind spot. Keep accelerating as much as possible in the left lane to allow a long enough gap for you and/or your riders to fit in front of the truck. Accelerate and maintain a higher rate of speed to allow yourself and others to pass the vehicle. Make sure the truck or bus and your riders are all visible in your rearview mirror before you pull in front with extra space. Avoid passing trucks and buses on a downgrade where

they tend to pick up speed. Never pass from the right lane. When a bus or truck is passing you, stay to the right and slow down slightly. Giving the driver room to pass safely helps get you out of the blind spot quicker. Remember to give trucks and buses plenty of space to merge in front of you when coming off ramps or changing lanes

### 3. Don't Cut It Close

Cutting in too close in front of another vehicle is always dangerous, but it's especially dangerous to "cut off" a commercial bus or truck. If you move in quickly from either side, you're likely to be in a blind spot so the driver may not see you in time. Even if you're visible, the vehicle may not be able to slow quickly enough to avoid a crash because of the amount of time it takes to stop. Trucks and buses may be slow to react so don't cut it close!

### 4. Stay Back

Tailgating a truck or bus presents added dangers. First, it puts you in a blind spot. Because trucks are so high off the ground, if you fail to stop in time (or get hit from behind)your motorcycle could slide under the truck. Getting too close when stopped is also dangerous– particularly on an upgrade, where a bus or truck might roll back. Allow plenty of room when stopping or traveling behind these trucks, buses and CMVs.

### 5. Give Them LOTS of Room

Anybody who has ever taken a road trip has seen areas where large chunks of rubber are all over the road. That rubber is from a blown out tire from a big rig. Most loaded trucks can legally weigh 80,000lbs or more. Can you imagine the stress that puts on tires? Semi tires are ticking time bombs. You don't want to get caught next to a big rig when the tire blows and shards of heavy rubber start flying at you. Not to mention there is a good chance the trucker will begin swerving as this happens. Always strive to stay away from trucks as much as possible on the roadway. And if you are riding near them, stay alert for tire blowouts and unpredictable swerving.

Fun Fact: At least 72% of car-truck crashes are caused by car drivers.

### 5. Anticipate Wide Turns

trucks have a 55 foot turning radius and so they require extra turning room They swing wide, or may even initiate a turn from a middle (rather than far right) lane. If a truck or bus has its turn signal on, never try to squeeze by it or get between the vehicle and the curb. When you stop at an intersection, never "block the box" or stop in front of the line, as buses and trucks require that space to complete turns safely.

#### 6. Be Patient

Trucks and buses have operating restrictions, and sometimes use technology like speed limiters. Honking, driving aggressively, or weaving through traffic won't make the trip faster, but can cause dangerous distractions and crashes. A truck may be in the left lane to pass another truck and while doing so cannot pass in an aggressively speedy manner due to their speed limiter. Stay safe and be patient!

#### Fun Fact: Did you know it takes a truck or bus 40% longer to stop than cars so do not cut it close!

Preparation is extremely important in staying safe. As Benjamin Franklin once said, "By failing to prepare you are preparing to fail". Preparation includes learning ways to stay safe, practice them and finally, use them. When you ride your motorcycle, it is always important to ride in ways to keep yourself out of unsafe situations. Remember, you can't control what others do but you can control what you do so keep these guide-lines in mind while driving around trucks and you will be safer riding your motorcycle.


ing and to become immersed in these traditions that we carry forward.

### **Excelsior-Henderson Motorcycle Brand** to be Auctioned at Mecum



Mecum Casino. The Excelsi-

or-Henderson motorcycle brand and all its intellectual for \$117,500. property will be auctioned at the 27th annual Mecum Las Vegas Motorcycle Auction, which will run Jan. 23 -27 and present 1,750 motorcycles for auction.

Included in the purchase will be the ownership of the Excelsior-Henderson brand name, all federally registered trademarks, web domains and includes the previous motorcycle frame and engine designs, as well as the expired patents that can only be effectively exploited by the owner of Excelsior-Henderson.



Excelsior-Henderson was historically one of the "Big 3" among motorcycle manufacturers and saw

its greatest successes under the ownership and direction of Ignaz Schwinn, whose mighty two-wheeled empire in Chicago earned most of its profit from bicycles. From 1911-21, Henderson's were the only 4cylinder motorcycles produced in the U.S., and by the late 1920s, it was Excelsior-Henderson and Indian that dominated the 45 cubic-inch market with the Super X and Scout models. Their big models - the Henderson Four, as well as the Indian Chief and Four - were admired the world over, and were in many ways the most attractive and technically interesting motorcycles built

in the U.S.

The vintage Excelsior and Henderson motorcycles still in existence today are highly collectible and celebrated examples





### **Sturgis Motorcycle Museum** to double its size



The Sturgis Motorcycle Museum and Hall of Fame is set to double in size within three years, and the Hall of Fame portion will have its own campus. Meanwhile the Main Street location will get a major revitalization, courtesy of generous donations from supporters, board members and the Law Tigers.



"It's been a busy summer," says Sturgis Motorcycle Museum executive director Myrick Robbins. "Scott Peterson, of Scott Peterson Ford, has donated land for the second, larger Museum site," said Robbins. "This site will be off of Exit 32 and visible from the I-90. The Law Tigers are jump starting the building fund to ensure that the aggressive expansion plans are met, "Defendant Buffalo Chip Campground, LLC, knew or donating more than \$100K to our capital campaign

> "We are honored to be part of motorcycle history," said Ari Levenbaum, on behalf of The Law Tigers, a professional association of motorcycle injury lawyers who help riders every day. "There are some amazing

motorcycles on display and incredible heritage that needs to be shared with riders."

In addition to the donation of the site by Scott Peterson and the funding from the Law Tigers, board member Bruce Eide generously donated the fees for the



architectural design firm, 4FrontDesign, Inc. They have completed the preliminary plans for the second site. The larger building will house the Hall of Fame, pre-1938 collection and various galleries. "The overall facility will give the Museum space to offer educational programs, meeting and event space and a place for the community and visitors to experience motorcycling, learn about the great people of the Hall of Fame and their heritage," said Robbins.
