



#### Fonzie's 1952 Triumph TR5 motorcycle hasn't lost an ounce of cool

Back in the 1970s, when *Happy Days* was the most popular show on TV, there was no one cooler than Arthur Herbert Fonzarelli, the lovable hoodlum with a knack for catchphrases and a way with the ladies. Being something of a badass—but not *too* bad, because we're talking prime time TV here—he rode a motorcycle, of course. As motorcycles go, his Triumph Trophy TR5 500 remains a popultural icon second only to Captain America's.



Mick Lynch loved that bike. He was 20 when *Happy Days* premiered in 1974. He related to the Fonz and his buddies Richie Cunningham, Potsie Weber, and Ralph Malph because, like them, he

grew up in a middle-class neighborhood of a working class city, in his case, Kalamazoo. Like the Fonz, he had a knack for any-thing mechanical.

ABC added ape-hanger bars, bobbed front fender, peashooter mufflers, and a fictitious "7836" Wisconsin license plate.

They were at an auction in nearby Belding in 1996, looking for anything they could use and decided there wasn't anything they couldn't live without. Lisa asked if Mick wanted to check out the car auction.

While surveying the vehicles, Lynch immediately recognized the 1952 Triumph TR5 parked in front of him. "I blurted out, 'That's the *Happy Days* motorcycle. Could that really be the real deal?" Yes, it was. The fellow next to him had exhaustively researched the bike and even talked to Bud Ekins, who helped the show's production team track it down all those years ago. "The guy asked me if I was going to bid on it, and I said, 'Not until you're out. If it goes beyond what you want to pay, I'll jump in."

Sure enough, the bidding exceeded the guy's budget. He nodded to Lynch, who raised his hand. After a bit of back and forth with other bidders, the auctioneer dropped the hammer.

At this point, you may be thinking, wait a sec—didn't Fonzie's Triumph sell for \$179,200 at Julien's Hollywood Legends Auction last year? Yes and no. Yes, *a* bike that Fonzie rode in the show sold, but not *the* bike Fonzie rode. Lynch says that motorcycle, a 1949 Triumph TR5, did indeed appear on *Happy Days*, but the '52 is the primary bike that was used during the show's 11-season run. "It's the one in the opening credits, the one in 90 per-

cent of the still shots," he says. "It's the bike on the posters, lunchboxes, and Thermoses."

The More Roads to Harley-Davidson accelerated plan for growth is aligned with the + company's strategy to deliver sustainable growth and build the next generation of riders by delivering exciting products in existing and new spaces, broader access to Harley-Davidson and an optimized customer experience through + an even stronger dealer network. The company plans to maintain its current investment and return profile and capital allocation strategy, while it funds strategic opportunities expected to drive revenue growth and expand operating margin through 2022.

During the quarter, Harley-Davidson made further progress on its More Roads plan, including appointing its first -ever brand president, a move that positions the company to fully engage the power of the brand as a catalyst to achieve its strategy and long-term objectives. The company also expanded its electric portfolio with the acquisition of StaCyc, a maker of electric two-wheelers for kids. During the quarter, the company and its dealers continued preparations to launch LiveWire, Harley-Davidson's first electric motorcycle, later this year.

"In the short eight months since we announced our More Roads plan, we continue to accelerate our progress to build the next generation of Harley-Davidson riders," said Levatich. "During the first quarter we intensified our march by investing in our future and adding capabilities that we're confident will inspire riders today and for generations to come."

#### **Building Riders**



As Harley-Davidson continues to inspire diverse, new riders around the globe, the company increased its reach and impact in the first quarter and delivered a wide range of results including the following highlights:

New, more diverse customers

- 278,000 new riders joined Harley-Davidson in 2018 in the U.S. This group is the most diverse across age, ethnicity and gender in all of the years Harley- For the full-year 2019, the company continues to expect: Davidson has tracked this data
- Expanded access to new customers in part with the launch of the new Electra Glide Standard motorcycle at \$18,999 U.S. MSRP
- Increased marketing support reached more consumers

#### Manufacturing



The company started supplying motorcycles to ASEAN (Association of Southeast Asian Nations) emerging markets from its Thailand operations in late 2018. The tariff mitigation realized by this strategy allowed more competitive pricing and helped drive a Q1 retail sales increase of 126 percent in these markets.

To further improve its manufacturing operations and cost structure, in the first quarter of 2018 the company commenced its multi-year manufacturing optimization initiative anchored by the consolidation of its motorcycle assembly plant in Kansas City, Mo. into its plant in York, Pa. Upon completion of the program, the company continues to expect ongoing annual cash savings of \$65 million to \$75 million after 2020. In the first quarter of 2019, costs related to the manufacturing optimization were \$17.6 million. For the full year, the company expects to realize savings of \$25 million to \$30 million and to incur \$50 million to \$60 million of operating expense.

The U.S. 601+cc industry was down 4.7 percent in the first quarter compared to the same period in 2018. Harley-Davidson's first quarter U.S. market share was up 0.6 pts to 51.1 percent. Harley-Davidson's Europe market share was down 1.6 percentage points to 8.8 percent.

#### 2019 Outlook

Motorcycle shipments to be approximately 217,000 to 222,000 motorcycles. In the second quarter, the company expects to ship approximately 65,500 to 70,500 motorcycles

# U.S. Tariffs Affecting European Motorcycles and Accessories



According to the Motor-cycle Industry Association, the U.S. government announced that they will likely introduce a 100% tariff on a number of imports from the EU, which will have a direct impact on several product groups in the motorcycle industry.

This proposal is in response to a WTO investigation of government subsidies to Airbus and is unrelated to tariffs around steel imports. Hearings in the U.S. are set for the month of May with an expectation that a decision on which goods to charge and a start date will be made shortly thereafter.

In terms of whole vehicles, the current list of products includes all combustion engine motorcycles with an engine capacity between 500cc and 700cc.

With regard to other products, the items listed also includes parts and accessories directly related to motorcycles.

The Motorcycle Industry Association is working closely with the UK government and scheduled a meeting with the Minister for early May.

# Parking violators rejoice— Court of Appeals rules that chalking tires is unconstitutional



A three-judge panel of the U.S. Court of Appeals for the 6th Circuit has unanimously ruled that chalking tires is a

violation of the Fourth Amendment because it is a form of trespass and requires a warrant. The ruling is bad news for law enforcement officers in who use chalk to mark the tires of cars to enforce time limits on parking. That's exactly what Alison Taylor claims a Saginaw, Michigan, police officer has been doing for three years while issuing her 15 parking tickets.

According to the Associated Press and National Public Radio, Taylor alleges Officer Tabitha Hoskins issued every one of her fines after first chalking a tire and then returning to see if Taylor's car had moved. Taylor sued, claiming that the practice constitutes "unreasonable search and seizure" and is therefore unconstitutional. The court agreed.

Philip Ellison, Taylor's attorney, wrote in a court filing:

"Trespassing upon a privately-owned vehicle parked on a public street to place a chalk mark to begin gathering information to ultimately impose a government sanction is unconstitutional under the Fourth Amendment."



The court ruled that chalking is indeed a search because government officials physically trespass upon a constitutionally protected area to obtain information. In 2012, the U.S. Supreme Court ruled that a warrant is required before placing a GPS tracking device on a vehicle, and the 6th Circuit Court of Appeals determined that the same is true by covertly chalking a tire in order to monitor a car's movements.

The court wrote that by chalking, the city of Saginaw illegally searches vehicles "that are parked legally, without probable cause, or even so much as 'individualized suspicion of wrongdoing'—the touchstone of the reasonableness



standard." The case will now head back to U.S. District Court in Bay City, Michigan.

Taylor's attorney says his client doesn't think anyone deserves free parking, and the lawsuit is about principle. "The process (that) Saginaw selected is unconstitutional," Ellison says.

Taylor is happy that she helped "change the law," but any celebration will likely be short-lived. While the method of physically chalking a tire may end, the practice likely won't. Officers can simply take a photo, effectively chalking the car without touching it.

May 5th will be the 4Bs ride. Brunch, Boats, & Birds with your TC Buddies. See Page 8 or the TC Calendar for full details.












Considered precious by knowledgable riders and never exposed by the pros. When fully in view, allows immediate indentification of untrained person not using his. Hand out rider education info on site!

#### EYES, EARS & FACE

Known to experienced riders as "bug and garbage collectors." Common "bare-face" symptoms include windblast-deafening and deformed, narrow-sit, watery eyes.

#### HAND!

au naturale [not for long]. Known to seize into curled position when exposed to cold; not genetically evolved to withstand abrasion.

#### **BARE LIMBS**

A phenomenon seen only on riders deemed impervious to any unavoidable accident or inclement weather. Subject to ridicule in riding circles.

#### FLIP FLOPS

Terminology for what sandals, toes and feet do upon contact with road surfaces, shift lever, brake pedal, footpegs, or windblasts.

#### BOTTOM LINI

Foot's gear identifies an untrained rider. Learn how to avoid embarrassment, ridicule and injury, while gaining skilts and knowledge by contacting the Rider Course nearest you.


