When Wet or DRY?

Fall has arrived and will soon may be wet and starting to award us with its beautiful decay causing very slippery colors. There is no better way oil-like conditions. to experience and enjoy these riding you always try to

colors than riding a motorcycle on the open roads.

However, Fall also presents us with its own unique set of road hazards. Being aware of them and watch- Falling leaves can also cover and camouflage road ing out for them is critical.

Fall brings beautifully colored leaves and wonderful smells of harvest. That's the good side of fall that we love and look forward to. The other side of that coin is the leaves falling, covering roads and harvest season with its busy time for farmers and their equipment.

The first thing we need to be aware of and understand is our Contact Patch. This is the location point at which our tire meets the road. With a motorcycle, the contact patch is only a few square inches under each tire. This means as a motorcycle rider you cannot afford to have anything between your tire and the pavement effectively eliminating our contact patch. In the fall, such things as leaves, dirt clumps, seeds, grains and loose gravel are more common.

Leaves hold moisture and as they start to decay, they terial on the generate more moisture. The leaves on the top of a roads, either

wise, you should do your best to avoid leaves.

hazards. What may appear to be a small pile of leaves may not be a pile at all but in fact, a few leaves covering an obstruction on the road such as a rock, stick, or chunk of asphalt. Patches of leaves may also cover other serious road obstructions such as potholes, large cracks, and uneven road surfaces.

During harvest, farmers are pulling their equipment in and out of the fields leaving long tracks of dirt and mud from their tires on the roads. They are also loading and hauling corn and beans that often spill out on the roads.

Riding a motorcycle through such spill can be very dangerous. This mapatch or wet or dry, is pile may like riding small dry marbles.



The best thing to do while enjoying all the beauty of a fall ride is to make an effort to avoid riding through those tempting piles and patches of leaves. Keep alert for corn and grains that may have fallen from farm wagons or trucks. Avoid any mud and dirt tracks on the roads from the farm equipment. Most of all enjoy the uniqueness of fall, ride safe, and get out there and take in those fall smells and see those beautiful colors!

> The stop sale was issued in early September, and for a while, the circumstances spawned plenty of conspiracy theories until the company issued a press release. You can still buy and sell used bikes, just

not from a BMW dealership. It covers every product BMW has, new and used, except for the electric CE 04 scooter.

The fact that all used BMWs are included suggests that the issue may have been going on for a while, but that hasn't been confirmed. Whether the federal government is involved, and whether there will be a recall, is unclear.

The timing of the stop sale notice may be unfortunate, as the company is about to introduce its new flagship, the R 1300 GS. Whether or not this issue will affect the North American launch of that bike is unknown. (Continued on pg 5)

The driver's license is generally to expire after ten mean that the acquisition of class A would only be years, for people over 60 every seven years, from 70 possible after two years of prior possession of class every five years and from 80 every two years. These A2. proposals have triggered a wave of discussion and disagreement, especially among the EU's older citizens.

This is because there are also calls for the introduction of compulsory medical-psychological examinations for older drivers, at a cost. Critics argue that this measure could be perceived as discriminatory and also represents a financial burden for those affected. Proponents, on the other hand, stress the need for such examinations to ensure road safety, especially in view of increasing life expectancy and the increase in older drivers on the roads.

Restriction and graduated driving licenses:

A restriction of Class B car licenses to vehicles with a maximum unladen weight of 1.8 tons is desired. Accordingly, Class B should be divided into two levels: Class B for lighter cars and Class B+ for heavier cars. The idea behind this is that novice drivers should first gain experience with lighter vehicles before being allowed to switch to heavier ones.

Speed limit and night driving bans for novice driv- incidents. ers:

Another concise point in the draft amendment to the EU driving license directives is the introduction of a 90 km/h speed limit and night driving bans for novice drivers. Accordingly, EU member states could impose a night driving ban for novice drivers between midnight and 6 am. The primary goal of this measure is to reduce the number of trips made under the influence of alcohol, which poses an increased risk, especially at night.

New probationary period regulation:

Another issue in the draft amendments relates to probationary period regulations. Under the new proposals, each newly acquired driver's license class would start with its own probationary period. Specifically, this means that if someone already holds a passenger car driver's license and later acquires a motorcycle license, a new probationary period would begin for them.

Possible changes for motorcycle and trike riders:

One significant proposal discussed in the new guidelines affects motorcycle and trike riders. Currently, Class A is required to ride all motorcycles and trikes, which can be obtained either through a graduated license or direct entry (minimum age 24). However,

Major Harley-Davidson Softail recall



A brittle fastener on the rear shock absorber is forcing Harley-Davidson to initiate a large-scale safety recall for select 2018 through 2023 Softail models. 65,224 potentially affected machines and first documented

The source of the problem: a brittle fastener.

Harley-Davidson Motor Company contacted the U.S. National Highway Traffic Safety Administration (NHTSA) to initiate a safety recall for select 2018 through 2023 Softail models. The reason is a specific type of mounting element on the rear shock absorber. If this element fails, the shock absorber can come into contact with the rear tire, potentially causing a tire failure and increasing the likelihood of a crash.

Which models are affected?

According to the company's own data, approximately 65,224 Softail motorcycles could have this defect, which represents about one percent of total production. However, it's important to note that not every Softail manufactured between 2018 and 2023 is affected by this recall. Only those models that have the problematic shock absorber manufacturer installed will need to be taken to the repair shop.

Model details and time frame

The affected machines were manufactured between June 28, 2017 and August 7, 2023. The recall covers various Softail models and production years. However, the company did not specify specific VIN ranges in the recall notice.

An initial alert could come from strange noises that appear to be coming from underneath the seat. In addition, the discovery of a loose shock adjuster after removing the seat could be an indicator. Other signs could be in the ride or unusual wear on the rear tire.

How did Harley-Davidson respond?

first service request in this matter. As of early August, a total of 33 cases have been documented where the rear shock has come into contact with the tire. Four of these cases resulted in a loss of pressure in the tire, but no cases involving injuries have been recorded to date.

Next steps and repair measures

For affected machines, the fastener on the shock absorber will be replaced free of charge at authorized Harley-Davidson shops. Those who have had appropriate work performed prior to the recall may be eligible for a refund under certain circumstances.

Communication channels and additional notices

Affected owners should be notified directly by Harley-Davidson between Sept. 8 and Sept. 15, 2023. Those with questions can contact the company's customer service department or NHTSA. In addition, a separate recall exists for specific shock adjusters that were sold as accessories.

Overview of affected models and production years

To help keep track, here is the list of models and production years included in the recall:

- 2018: FLDE (2018 units), FLHC (2917 units), FLHCS (3504 units), FLHCS ANV (898 units).
- 2019: FLDE (1858 pieces), FLHC (2078 pieces), FLHCS (3384 pieces)
- 2020: FLHC (1896 pieces), FLHCS (3713 pieces), FXLRS (7073 pieces)
- 2021: FLHC (1865 pieces), FLHCS (3134 pieces), FXLRS (5811 pieces)
- 2022: FLHCS (3957 pieces), FXLRS (5186 pieces), FXLRST (3990 pieces), FXRST (738 pieces)
- 2023: FLHCS (3033 units), FLHCS ANV (717 units), FXLRS (3340 units), FXLRST (4114 units)

The motorcycles that fall within this list were produced between June 28, 2017 and August 7, 2023. So far, no specific VIN ranges have been named for the recall.

Ride Safe and Vote, Vote, Vote!

The most important thing we do in Top Cats is safe riding. The second most important thing we do is smart voting. Our riding season has been a safe one and now it's time to vote in our annual Club elections.

For the 2024 - 2025 term, consistent with our By Laws, we have the following five position vacancies and current qualified incumbents or nominees:

I. Vice President (2024-2025):

Requirements for Vice President

1. Be a Full Member in good standing for 3 consecutive years prior to the date of the election.

2. Have served as a committee chairperson for one year or have served a minimum of

one year in any Board position.

3. Have no history of disciplinary action.

II. Secretary (2024-2025):

Requirements for Secretary

1. Have been a Full Member in good standing for 1 year prior to the date of the election.

2. Have no history of disciplinary action.

III. Treasurer (2024-2025):

Requirements for Treasurer

1. Have been a Full Member in good standing for 1 year prior to the date of the election.

2. Have no history of disciplinary action.

IV. Two Directors (2024 - 2025):

Requirements for Director

1. Be a Full member in good standing for 12 months prior to the date of election.

2. Have served as a committee member for one year or have served a minimum of one year in any Board position.

3. Have no history of disciplinary action.

Nominations for Vice President, Secretary, Treasurer and two Directors will be accepted up to 1 November via email to <u>wkirkpa177@aol.com</u>, or in person. When you find yourself faced with a nomination decision, simply look at your choices and determine who has the <u>best interest</u> of the Club at heart, who has a <u>proven record</u> of dedication to the Club, who has the <u>experience</u> for that particular position and, if all else is a tie, ask yourself who you see at every ride, every meeting, every committee activity, every Club event, and every charity ride. That should help you decide.

Nominees will be vetted for eligibility and the slate will be reviewed and approved by our Board in November. Voting will take place at our 5 December general meeting and our new Board will take office on 1 January 2024. Our ballot - voting procedures will be explained in the November and December issues of ROAR.

Remember, to be eligible to vote, you must be a Member in Good Standing. That requires you to meet the following requirements by November 30th of each calendar year. (New members will become eligible to vote following their 12 month probationary status.)

- Attend a minimum of 5, official Top Cats events per year.
